- (d) if so, the details thereof; and
- (e) if not, the reasons therefor?

(a) As on date, 2,55,777 Gram Panchayats across States have uploaded their Gram Panchayat Development Plan for the year 2021-22 in eGram Swaraj application. State-wise details is given in **Annexure -I.**

(b) The Gram Panchayat Development Plan for the plan year 2021-22 involve 51,01,301 activities out of which 6 activities have been completed so far. State-wise details is given in **Annexure -II.**

(c) Yes Sir.

(d) As part of Digital India Programme, the Government is implementing eGram Swaraj, a work-based accounting application under e-Panchayat Mission Mode Project to revamp the functioning of Panchayati Raj Institutions (PRIs). eGram Swaraj addresses various aspects of Panchayat functioning such as planning, accounting, budgeting including online payments through eGram Swaraj-PFMS interface for enhancing transparency and accountability.
