Will the Minister of Coal be pleased to state:

- (a) whether Government is aware of the under-utilization of existing coal mines in India and whether any action has been taken to enhance such utilisation;
- (b) if so, the details thereof and if not, the reasons therefor; and
- (c) the details of Public Sector Enterprises (PSEs) which were allocated coal blocks, from 2014 till date, and the details of cancellation of allotted mines to PSEs during this period, if any, year-wise?

(a) & (b): Yes Sir. Government is aware of the under-utilization of existing coal mines in India. Main reasons for less capacity utilization are delay in land acquisition, EC restrictions in some mines, extended or excess rain some years, unexpected geological disturbances, poor performance of some of the OB removal contractors, COVID-19 pandemic etc. Steps are being taken to improve the efficiency of mines:

(i) These projects are regularly monitored by the Government as well as Coal Companies and necessary actions are initiated for early completion of projects. The issues related to EC, FC, Land acquisition and R&R are rigorously followed up at District and State level for early resolution.

(ii) Regular liaison is being done for availability of permissions, clearances, land acquisition.

(iii) High capacity HEMM is being introduced wherever feasible to enhance production and productivity.

(iv) OB removal and coal transportation contracts are being awarded in advance.
