PIPED WATER CONNECTION IN RURAL POPULATION

1531# SHRI HARNATH SINGH YADAV:

Will the Minister of JAL SHAKTI be pleased to state:

- (a) the salient features of Jal Jeevan Mission;
- (b) whether it is a fact that at the time of inception of this ambitious mission, out of total household of the country, piped water connection was available only to 17 per cent rural population;
- (c) if so, the details thereof, details of piped water connections available to rural population as on date, State-wise; and
- (d) whether Government has any action plan to provide piped water in every rural household by 2024 by following the 'Sabka Sath, Sabka Vikas' slogan, if so, the details thereof?

ANSWER

THE MINISTER OF STATE FOR JAL SHAKTI (SHRI PRAHLAD SINGH PATEL)

- (a) To enable every rural household to have provision of potable tap water supply by 2024, Government of India in partnership with States, is implementing Jal Jeevan Mission (JJM) Har Ghar Jal. The key features of the Jal Jeevan Mission (JJM) are to make provision of potable water to every rural household and other public institutions in villages like schools, anganwadi centres, ashramshalas, health centres, etc. through tap water connection.
- (b) & (c) On 15th August, 2019, at the time of announcement of Jal Jeevan Mission, out of 18.93 Crore rural households, 3.23 Crore households (17%) were reported to have tap water connection. Since then, 4.60 Crore (24.09%) rural households have been provided tap water connections, thus, as on date, 7.84 Crore (41%) rural households have provision of tap water supply. The State/ UT-wise details of the number of households that are having provisions of tap water supply in their homes is at **Annex**.
- (d) Following the principle of 'no one is left out', every rural household in villages is being provided tap water connection under JJM. So far, in 76 districts and 1.05 lakh villages, provision of tap water supply to every household has been made in line with the motto of 'Sabka Sath, Sabka Vikas.' Further, provisions have been made for prioritizing tap water supply in water-quality affected habitations, desert and drought-prone areas, Aspirational and JE–AES affected districts, SC/ST majority villages, Saansad Adarsh Gram Yojana (SAGY) villages, etc.
