## "PROPOSAL TO INCREASE HOSPITALS OR MEDICAL COLLEGES IN THE STATES"

1707 Shri Vijay Pal Singh Tomar: Shri Harnath Singh Yadav: Lt. Gen. (Dr.) D.P. Vats (Retd.):

Will the Minister of Health and Family Welfare be pleased to state:

- a) whether Government proposed to increase hospitals or medical colleges in various States of the country;
- b) whether it is also a fact that there is shortage of doctors in the country
- c) if so, whether the number of seats for MBBS have been increased in the recent past, if so, the details thereof, State-wise; and
- d) the number of registered MBBS doctors in the country, State-wise till date?

# ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (DR BHARATI PRAVIN PAWAR)

- (a): The Ministry of Health and Family Welfare administers a Centrally Sponsored Scheme namely 'Establishment of new Medical Colleges attached with existing district/referral hospitals'. Under this scheme, Government of India has approved establishment of 157 new medical colleges in three phases. Out of these, 47 medical colleges have become functional till date. Also, under the Pradhan Mantri Swasthya Suraksha Yojna (PMSSY), 22 new AIIMS have been approved.
- (b) to (d): There are 12.68 lakh allopathic doctors registered with the State Medical Councils and the National Medical Commission (NMC). Assuming 80% availability of registered allopathic doctors i.e. 10.14 lakh allopathic doctors and another 5.65 lakh AYUSH doctors, the doctor-population ratio comes to 1:854 in the country. During the last six years, MBBS Seats in the country have increased by 53% from 54,348 seats in 2014 to 83,275 seats in 2020 State-wise details of MBBS seats are at Annexure I. The details of registered allopathic doctors are at Annexure II.
