STATUS OF BHARATNET PROJECT

1930 Shri Akhilesh Prasad Singh:

Will the Minister of Communications be pleased to state:

(a) the details of aims and objectives of Phase-I of BharatNet Project;

(b) the funds sanctioned, allocated, released and utilized during each of the last three years and the current year, State/UT-wise;

(c) the targets fixed and the achievement made by Government thereunder, State/UTwise, including Bihar and Jharkhand along with the progress made on the said project;

(d) whether progress on Phase-II of the project is going on as per schedule;

- (e) if so, the details thereof; and
- (f) if not, the reasons therefor?

ANSWER

MINISTER OF STATE FOR COMMUNICATIONS (SHRI DEVUSINH CHAUHAN)

(a) The aim & objective of Phase-I of the BharatNet was to provide broadband connectivity to around 1 lakh Gram Panchayats (GPs) in the country. This was done by laying underground incremental optical fibre cable in linear topology with Gigabit Passive Optical Network (GPON) technology. The infrastructure created under BharatNet is a national asset, accessible on non-discriminatory basis to all Service Providers. The Phase-I was completed in December 2017 under which more than 1 lakh GPs were connected. The implementation of the Phase-I (Revised workfront) is also almost complete, as 1,18,649 GPs have been made Service Ready out of the targeted 1,20,392 GPs.

(b) The total sanctioned/approved cost for BharatNet project is now Rs. 61,109 crore. This includes Rs. 42,068 crore for BharatNet (Phase-I and Phase-II) and a maximum of Rs. 19,041 crore on Viability Gap Funding (VGF) for implementation of the Public Private Partnership (PPP) model of BharatNet in 16 States of the country covering about 3.61 lakh villages including GPs.

The details of State/Union Territory (UT)-wise funds allocated/released/utilized during each of the last three years and the current year under BharatNet project, are given in **Annexure-I**.

(c) The State/UT-wise details of the planned GPs and Service Ready GPs, in the country (including Bihar and Jharkhand) under BharatNet project, are given in Annexure-II.

(d) to (f) Under BharatNet Phase-II, as on 09.07.2021, a total of 39,270 GPs have been made Service Ready. The implementation of the Phase-II is affected mainly on account of:

(i) GPs are widely dispersed across remote corners of the country, covering difficult terrains (including Hilly/ Rocky) and also difficulty for access in Left Wing Extremism (LWE) affected areas;

(ii) Under BharatNet Phase-II, about 65,000 GPs in 8 States are being implemented by the State Governments under State-led model. The implementation of the same is not meeting the targeted time-lines and is adversely affecting the completion of the Project.

(iii) Since March 2020, pursuant to lockdown and movement restrictions due to COVID-19, the progress of the project has been adversely affected.
