### PAYMENT TO BSNL EMPLOYEES

#### 1942# Shri Sushil Kumar Modi:

Will the Minister of Communications be pleased to state:

(a) the total number of employees who worked in BSNL and the number of employees who have taken VRS;

(b) the outstanding amount to be paid to BSNL by the department, by when Government would pay this amount;

(c) the amount already paid to the employees who took VRS and the details of the outstanding amount; and

(d) the details of the provision made for VRS and capital expenditure in the budget of year 2020-21 and the details of the expenditure incurred?

#### ANSWER

### MINISTER OF STATE FOR COMMUNICATIONS (SHRI DEVUSINH CHAUHAN)

(a) Total number of employees of Bharat Sanchar Nigam Limited (BSNL) as on 01.01.2020 were 1,49,577. 78,323 employees, thereafter have retired voluntarily under Voluntary Retirement Scheme (VRS).

(b) & (c) In respect of employees who opted for VRS, no amount is outstanding to be paid to BSNL by the Department. The Government has paid Rs.13,542.05 crores to BSNL towards ex-gratia for the employees who opted for VRS. BSNL has informed that in very few cases, it has not paid ex-gratia to those employees where vigilance clearance and caste certificate verification is pending.

(d) Detail of the provisions made for VRS in the budget and the expenditure incurred during the year 2019-20 and 2020-21 are as under:
