Will the Minister of **Education** be pleased to state:

- (a) the number of Centres for the Study of Social Exclusion and Inclusive Policy in the country;
- (b) the year-wise and university-wise details of budgetary allocation and funds spent on 'Centres for the Study of Social Exclusion and Inclusive Policy' from 2016-17 to 2020-21;
- (c) whether it is a fact that Government has stopped funding these Centres in recent years; and
- (d) if so, the details thereof and if not, the reasons therefor?

- (a): The University Grants Commission (UGC) has informed that 29 Centres are continuing under the UGC scheme of establishment of Centres in Universities for Study of Social Exclusion and Inclusive Policy.
- (b): The UGC has informed that the grants are released to the centres on reimbursement basis. The Year-wise and University-wise details of grants released during 2016-17 to 2020-21 are at Annexure.
- (c) & (d): The UGC has continued the scheme of establishment of Centres in Universities for Study of Social Exclusion and Inclusive Policy up to 31-03-2022.
