**DIGITAL DIVIDE IN THE COUNTRY**

**1997 SHRI DEREK O' BRIEN:**

Will the Minister of Electronics and Information Technology be pleased to state:-

- (a) whether Government has estimated the latest level of internet penetration or any such proxy, State-wise, in the country and if so, the details thereof;
- (b) whether there exists a digital divide between rural and urban India at present; and
- (c) if so, the steps being taken to address this gap?

**ANSWER**

(a): As per Telecom Regulatory Authority of India (TRAI) as on 31<sup>st</sup> March 2021 there are 82.53 crores (825.301 million) internet subscribers in the country. The service area wise rural and urban internet users in the country as on 31<sup>st</sup> March, 2021 is at **Annexure 1**.

(b) and (c): Specific to address the objective of increasing internet availability and access in rural India, Government of India has implemented BharatNet project in all the Gram Panchayats (GPs) and villages of the country. As on 01.07.2021, a total number of 1,57,383 GPs have been made service ready with high speed internet/ broadband infrastructure. Till date 5,25,706 km optical fiber is laid down across the country.

In addition, various schemes are being implemented under Universal Service Obligation Fund (USOF) to enhance mobile internet services in the rural and remote areas of the country including North Eastern Region (NER), areas affected by Left Wing Extremism(LWE), Border areas, Aspirational Districts and Islands.
