RELEASE OF GRANTS UNDER VARIOUS SCHEMES

Will the Minister of Panchayati Raj be pleased to state:

- (a) the details of grants released under various schemes of the Ministry during each of the last three years;
- (b) whether the said grants were released on time during the said period;
- (c) if so, the details thereof along with the scheme-wise/year-wise/State-wise details of the grants released so far; and
- (d) the sector-wise details of utilisation of the said grant/expenditure made during the said period?

(a) Grants released under the schemes of Rashtriya Gram Swaraj Abhiyan (RGSA), Incentivization of Panchayats (IoPs) and Survey of Villages and Mapping with Improved Technology in Village Areas (SVAMITVA) during the last three years are as follows:

(b) Release of grants under the schemes of the Ministry is contingent upon receipt of utilisation certificates of the previous grants, release of State share, wherever applicable (RGSA scheme) and hence the said grants have been released on fulfilment of the above conditions.

(c) The scheme-wise/year-wise/State-wise details of the grants released during the last three years is at **Annexure**.

(d) An amount of Rs. 1273.93 crore has been utilised for meeting the infrastructural need, training and capacity building of the Panchayat Raj Institutions under the RGSA scheme. An amount of Rs.114.30 crore has been utilised as incentives in the form of award money released to the Panchayats for their good works selected under National Panchayat Award. Under the SVAMITVA scheme, Rs.2.47 crore has been utilised for Information, Education and

Communication (IEC) activities and State Project Management Unit (SPMU) for implementation of the SVAMITVA scheme.
