TEXTILE AND APPAREL PARKS IN THE COUNTRY

2056. SMT. PHULO DEVI NETAM:

Will the Minister of TEXTILES be pleased to state:

- (a) the details of Apparel Parks, Mega Apparel Parks, Textile Parks etc. established in the country;
- (b) whether Government proposes to set up common infrastructure including Mega Apparel Park, Textile Park for the development of the textile industry; and
- (c) the schemes being run for the textile industry, the details thereof?

ANSWER

(a) & (b): Under Scheme for Integrated Textile Park(SITP) launched from the 11th Five Year Plan, 66 parks have been sanctioned. Out of 66 Parks, 10 were cancelled, 24 have been completed as per scheme guideline and 32 are under implementation at various states. List of such Parks is given in Annexure.

In the Union Budget 2021-22, it has been announced that a scheme of Mega Integrated Textile Regions and Apparel Park will be launched. Under the scheme, seven Mega Textile Parks will be set up in the country over 3 years. Ministry of Textiles is in the process of obtaining approval of the Cabinet for the scheme.

(c): Government is implementing various schemes such as Amended Technology Upgradation Scheme(ATUF), National Handloom Development Programme(NHDP), National Handicraft Development Programme, PowerTex India - A comprehensive scheme for development of Powerloom sector, Comprehensive Powerloom Cluster Development Scheme, Silk Samagra, Jute (ICARE)- (Improved Cultivation and Advanced Retting Exercise), Integrated Wool Development Programme, SAMARTH- Scheme for Capacity Building in Textiles Sector, Technical Textiles etc. for overall development and promotion of domestic manufacturing and exports in textile sector in the country.

Further, in order to ensure adequate availability of raw material at competitive price in the country, Government has removed anti-dumping duty on Purified Terephthalic Acid (PTA) (a key raw material for the manufacture of MMF fibre and yarn) originating in or exported from the People's Republic of China, Iran, Indonesia, Malaysia, Taiwan, Korea R P and Thailand to India and also removed anti-dumping duty on acrylic fibre (raw material for acrylic yarn and knitwear industry) originated in or exported from Thailand to India.

Government has also given its approval for continuation of Rebate of State and Central Taxes and Levies (RoSCTL) on exports of Apparel/Garments and Made-ups till 31st March 2024. The other textiles products which are not covered under the RoSCTL shall be eligible to avail the benefits, if any, under Remission of Duties and Taxes on Exported Products (RoDTEP) along with other products. The remission of duty and tax under RoSCTL and RoDTEP scheme will make products cost competitive in the international markets.

Further, Focus Product Incentive scheme and Mega Integrated Textiles Region and Apparel Parks scheme are also under formulation to support textiles industry.
