the allocation and utilisation of funds under different schemes of the Ministry for Uttar Pradesh, Andhra Pradesh and Telangana since 2017-18, year-wise including the present year so far?

Under different schemes of Ministry of Textiles, funds are not allocated State-wise. Financial assistance is provided to eligible agencies under various schemes based on the merit of the proposals. The funds released under the schemes i.e. Amended Technology Fund Scheme (ATUFS), National Handloom Development Programme (NHDP), Schemes implemented by O/o DC (Handicrafts), Silk Samagra, National Institute of Fashion Technology (NIFT), Samarth (Scheme for Capacity Building in Textile Sector), Integrated Wool Development Programme (IWDP), PowerTex and Scheme for Integrated Textile Parks (SITP) to the States of Uttar Pradesh, Andhra Pradesh & Telangana during 2017-18 to 2021-22 are at tables I, II, III, IV, V, VI, VII, VIII and IX at Annexure.
