(a) whether the level of registration of births and deaths in the country improved in 2019, according to the 'Vital Statistics of India Based on The Civil Registration System' report and some States and Union Territories were, however, lagging behind; and

(b) if so, the details thereof, State/UT-wise as on date and the reasons therefor?

(a) & (b): As per the Report on 'Vital Statistics of India based on the Civil Registration System for the year 2019', the level of registration of births has increased from 87.8% in 2018 to 92.7% in 2019 whereas the level of registration of deaths has increased from 84.6% to 92.0% during the period. State wise level of registration of births and deaths for the year 2018 and 2019 is given at Annexure.
