- (a) 26 Cadets became disabled during training in Indian Army in 2019-20 as per Appendix.
- (b) & (c): No alternative employment in Army was provided to any disabled cadet. However, Sanction of Government of India exists for according Priority-1 for the purpose of employment, to cadets boarded out on medical grounds attributable to Military Training (Annexure).

**OFFICE MEMORANDUM**

**SUBJECT: GRANT OF PRIORITY TO RECRUITS/OFFICER CADETS WHO ARE MEDICALLY BOARDED OUT**

The undersigned is directed to say that the Committee on problems of ex-Servicemen had recommended that recruits/officer cadets who are boarded out on medical grounds attributable to their military training should be accorded Priority for the purposes of Employment.

2. The above recommendations have been examined in consultation with the Ministry of Labour (DGET), and it has been decided to accept the same. Consequently, the list of categories to whom priorities have been allowed circulated vide this Department's O.M. No. 14034/3/84-Estt(D) dated 31.07.1984 stands modified to the extent that under Priority I, recruits/officer cadets who are boarded out on medical ground attributable to their military training will now be included and shown at S. No.6.

3. Ministry of Finance, etc. are requested to bring the above decision to the notice of all concerned for necessary action.
