**POTABLE WATER SUPPLY THROUGH TAP**

**2329** SHRI K.C. VENUGOPAL:  
SHRI SANJAY SETH:

Will the Minister of JAL SHAKTI be pleased to state:

- (a) whether it is a fact that Jal Jeevan Mission (JJM) was launched to enable every rural household in the country to have assured potable water supply through tap by 2024;
- (b) if so, the number of households which have tap water connections and the number of remaining households which do not have tap water connections, State-wise; and
- (c) the steps Government is taking to implement this Mission on time?

**ANSWER**

(a) Since August 2019, Government of India in partnership with States, is implementing Jal Jeevan Mission (JJM) to enable every rural household to have potable tap water supply by 2024 in adequate quantity, of prescribed quality and on regular and long-term basis. After extensive deliberations, States/ UTs have firmed up their plan to make provision of tap water supply to every rural household, and timelines of the same, is as under:

In Goa, Telangana, Puducherry, A&N Islands and Dadra & Nagar Haveli and Daman & Diu, every household in villages have been provided with tap water connections.

(b) On 15th August, 2019, at the time of announcement of Jal Jeevan Mission, out of 18.93 Crore rural households, 3.23 Crore households (17%) were reported to have tap water connections. So far, 4.65Crore (24.32%) rural households have been provided with tap water connections. Thus, as of date, out of 19.12 Crore rural households across the country, 7.89 Crore (41.24%) households are reported to have potable tap water supply in their homes. The State/ UT-wise details of the number of householdsthat are having tap water connection and those are yet to be provided tap water connection, is **annexed**.

(c) A number of steps have been taken to plan and implement JJM with speed, inter alia, which includes joint discussion and finalization of Annual Action Plan (AAP) as well as saturation plan of States/ UTs, regular review of implementation, workshops/ conferences/ webinars for capacity building and knowledge sharing, field visits by multi-disciplinary team to provide technical support, etc. A detailed Operational Guidelines for the implementation of JJM; Margdarshika for Gram Panchayats & VWSCs to provide safe drinking water in rural households and Guidelines on 100–days campaign to provide piped water supply in anganwadi centres, ashramshalas and schools have been shared with States/ UTs, to facilitate planning and implementation of Jal Jeevan Mission. For online monitoring, JJM–Integrated Management Information System (IMIS) and online JJM–Dashboard has been put in place. Provision has also been made for transparent online financial management through Public Financial Management System (PFMS).
