**Will the Minister of Home Affairs be pleased to state:**

- (a) whether it is a fact that Government has identified three thousand more enemy properties left behind by Chinese and Pakistani nationals;**
- (b) if so, the details thereof, State-wise;**
- (c) the details of enemy properties so far with the Custodian of Enemy Properties for India; and**
- (d) the details of movable and immovable enemy properties that Government has so far put to sale and details of proceeds deposited in the Consolidated Fund of India?**

**(a) to (c): The identification of enemy properties is an ongoing process as per the provisions of the Enemy Property Act, 1968. As on date 12611 immovable enemy properties left behind by Chinese and Pakistani nationals are vested in the Custodian of Enemy Property for India (CEPI). The state-wise details of vested immovable properties are given in Annexure.**

**(d): So far, movable properties of Rs. 2706.91 Crores have been disposed of. This amount has already been deposited in the Consolidated Fund of India (CFI) account. No immovable enemy property has been sold so far.**
