THE PRIME MINISTER (DR. MANMOHAN SINGH): Mr. Chairman, Sir, I rise to inform this august House that the Government of India has reached agreement with the Government of the United States of America on the text of the bilateral Agreement on Cooperation for Peaceful Uses of Nuclear Energy. ...(Interruptions)...
