906. MS. SUSHMITA DEV:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the detail of the number of beneficiaries of Industrial Motivation Campaign, Entrepreneurship Awareness Programme (EAP), Entrepreneurship-cum Skill Development Programme (E-SDPs) and management development programme that has been conducted under the entrepreneurship skill development programme since its inception till date, State-wise;
- (b) what percentage of the beneficiaries of EAP and E-SDPs are women;
- (c) the details of total amount of funds sanctioned and utilized in Assam and West Bengal under the entrepreneurship skill development programme, district-wise; and
- (d) the details of the number of specific tailor made programmes for skill development of socially disadvantaged groups which have been organised in Assam district-wise?

ANSWER

MINISTRY OF MICRO, SMALL AND MEDIUM ENTERPRISES
(SHRI NARAYAN RANE)

(a): The number of beneficiaries under Industrial Motivation Campaign (IMC), Entrepreneurship Awareness Programme (EAP), Entrepreneurship-cum Skill Development Programme (E-SDPs) and Management Development Programme (MDP) are 192119, 28999, 36542 and 16582 respectively since 2018-19 (notification of scheme) as per data available on MIS portal. The State-wise details are attached in annexure-A.

(b): The percentage of women beneficiaries of EAP and E-SDP are 45.93 % and 55.06% respectively since 2018-19.

(c): The funds sanctioned and utilized in Assam is Rs. 145.3 lakhs and Rs. 129 lakhs, whereas in West Bengal is Rs. 61.65 lakhs and Rs. 50.2 lakhs respectively since 2018-19. The District-wise details are attached as Annexure-B.

(d): The total number of ESDP programmes conducted in Assam including socially disadvantaged groups are 240 since 2018-19. The District-wise details are attached as Annexure-C.
