# STATEMENT REFERRED TO RAJYA SABHA STARRED QUESTION NO. 128 FOR 9<sup>TH</sup> DECEMBER, 2021

The Government of India set up the Ministry of Tribal Affairs in 1999 with the objective of providing more focused approach on the integrated socio-economic development of Scheduled Tribes. It's efforts to preserve and promote art, culture & heritage of various tribal communities are supplemented by the Ministry of Culture through festivals, museums & preservation of vanishing arts.

The Government has declared 15<sup>th</sup> November, 2021 as Janjatiya Gaurav Divas dedicated to the memory of brave tribal freedom fighters so that coming generations can know about their sacrifices for the country. The Hon'ble Prime Minister inaugurated the "Bhagwan Birsa Munda Memorial Park cum Freedom Fighter Museum" at Ranchi on this day.

#### A. MINISTRY OF CULTURE:

#### > ZONAL CULTURAL CENTRES (ZCCs):

To protect, promote and preserve various forms of folk art and culture including tribal culture throughout the country, the Government of India has set up seven Zonal Cultural Centres (ZCCs). These ZCCs organize various cultural activities and programmes on regular basis in the country independently and in association with Tribal Cooperative Marketing Development Federation of India Limited (TRIFED) in which folk and tribal artists are engaged to showcase their talent enabling them to earn their livelihood. Details of activities undertaken by the ZCCs are briefly categorized as under:

- I. AADI MAHOTSAVS & AADI PARVS: Aadi Mahotsavs are organized by the ZCCs in association with TRIFED and Aadi Parvs (tribal fairs) are conducted by the ZCCs independently in their member States as given below:
  - North Zone Cultural Centre (NZCC), Patiala has taken various measures/ steps for conservation of number of customs, cultures and traditions of tribal community by organizing programmes, theatre shows, fairs, festivals etc. due to which large number of artists, artisans including artists of tribal folk dances and various art forms have been benefitted. NZCC organizes 'Tribal Fairs' in its member States.
  - South Zone Cultural Centre (SZCC), Thanjavur organizes special tribal festivals and Aadi Mahotsavs in association with TRIFED which includes performing arts and craft exhibition. In order to promote tribal artists, a special event of National Tribal Dance Festival was conducted during October, 2021 at Raipur, Chhattisgarh in which especial tribal art forms across the country were showcased.
  - North Central Zone Cultural Centre (NCZCC), Prayagraj organizes Aadi Mahotsavs in collaboration with Ministry of Tribal Affairs. NCZCC also organizes Rashtriya Shilp Mela, Kalagram Shilp Mela, Vividha Sanskritik Parv, Rashtriya Yuva Utsav, Yuva Chitrakar Shivir, Bundeli Barkha Bahar Mahotsava, Magh Mela, Tandi Workshop and Atulya Bharat showcasing tribal art forms. From November, 2018 to November, 2021, NCZCC organized four

Aadi Parvs, Kala Chaupal on Gondi Tribals, two workshops on Gaindi Folk Dance and Reena Saira Folk Dance.

- Eastern Zonal Cultural Centre (EZCC), Kolkata has formulated action plan through programmes, workshops and documentation to preserve and promote the art, culture and heritage of various tribal communities in its member States i.e. Assam, Andaman & Nicobar Islands, Bihar, Tripura, Sikkim, Jharkhand, Manipur, West Bengal and Odisha. The following programmes have been organized:
  - i. Adi Sapta Pallav a festival of tribal arts & heritage of West Bengal
  - ii. Adi Bimb Workshop a festival of Tribal Arts
  - iii. Adi Lok Rang promotion of folk and traditional theatre forms
- OCTAVE a festival of the North East which is organized by all seven Zonal Cultural Centres to promote folk culture of the North Eastern States by way of providing an exclusive platform to the artists and artisans of NE Region to promote and propagate their rich cultural heritage. Details of the Octave programmes organized during the last five years are at Annexure-I.
- **II. RESEARCH & DOCUMENTATION:** To preserve, promote and propagate vanishing visual and performing art forms, including folk, tribal and classical in the fields of music, dance, theatre, literature, fine arts etc. in print/ audio visual media. The art form is finalized in consultation with State Culture Departments.
  - The following workshops are conducted by EZCC to promote dying and vanishing art forms of tribal communities which helps them to earn their livelihood:
    - i. Chadar Badar
    - ii. Katum Kutum
    - iii. Dhokra Craft
    - iv. Lac Dolls

Further, the following art forms including tribal dances, tribal instruments, tribal paintings, tribal music, tribal arts and crafts, tribal festivals, tribal folk theatre have been documented by EZCC:

- i. Lepcha Documentary & Performances
- ii. Sherpa Performance
- iii. Dukpa Documentary & Performances
- iv. Tibetian Documentary & Performances
- v. Mech Performance
- vi. Rava Performance
- vii. Santhal Performance

Documented art forms are being utilized for promotion and dissemination of tribal art and culture among the young generation. Besides, the following activities are also undertaken:

- i. Tribal costumes/ musical instruments/ daily use utensils/ deities of tribal communities of the member States of EZCC have been displayed in the huts of the Srijani, Shilpagram to give an idea to the tourists and visitors about the tribal culture of the States.
- ii. Sending troupes to all tribal festivals across the country for promotion of culture of tribal communities.

- iii. In craft fairs products made by the tribal communities of the member states are sold.
- iv. The tribal craftsmen are given design inputs by experts through workshops in order to help them to improve their products.
- III. SHILPGRAM: To promote folk and tribal art and crafts of the zone, seminar, workshops, exhibitions, craft fairs are organized. Design development and marketing support are also provided to the artisans living in the rural areas. EZCC has opened one outlet in collaboration with TRIFED in EZCC complex. North East Zone Cultural Centre (NEZCC), Dimapur has opened three outlets at Shilpgram, Guwahati in collaboration with TRIFED.
- **IV. SCHEMES:** ZCCs also implement the following schemes where tribal artists are supported:
- i. Award to Young Talented Artistes: The Scheme "Young Talented Artists" is carried out to encourage and recognize the young talents especially in the field of rare art forms. Talented youngsters of the age group of 18-30 years are selected and given a onetime cash award of Rs. 10,000/-.
- ii. Guru Shishya Parampara: This scheme envisages transmitting our valued traditions to the coming generations. Disciples are trained under veterans in art forms which are rare and vanishing. Rare and vanishing art forms of the region are identified and eminent exponents are selected to carry out the training programmes in 'Gurukula' tradition. The monthly remuneration for Guru Rs. 7,500/-, Accompanist Rs. 3,750/- and Pupils Rs. 1,500/- each for the period of six month to maximum 1 year for one scheme. The names of the Gurus are recommended by the State Culture Departments.
- iii. Theatre Rejuvenation: To promote theatre activities including stage shows and Production oriented workshops, etc., Honorarium up to Rs. 30,000/- per show excluding TA & DA is paid. The groups are finalized on the basis of their credentials as well as the merit of projects submitted by them.
- iv. National Cultural Exchange Programme: Under this scheme, various festivals of performing arts, exhibitions, yatras etc are organized in member States. Artists from other zones/states are invited to participate in these programmes. Participation of artists from the zone in festivals held in other parts of the country is also facilitated.

#### > AKADEMIES:

- Sangeet Natak Akademi (SNA), New Delhi organizes various festivals including 'Deshaj' focused on folk and tribal performing arts all over the country, gives grants-in-aid for research, documentation and publishing documents and records of the performing arts for its audio-visual archive to preserve and promote performing arts of India including tribal culture. SNA have also organized Lok Jatra (festival of folk and tribal theatre expressions of India), Jan Pratha Utsav (festival of tribal performing arts of North East States), workshop on Bihu and Jeng Bihu dance, Lok Pratibha (festival of young folk & tribal artists) and Lok Sangam (festival of senior folk & tribal artists) showcasing tribal art forms.
- Sahitya Akademi (SA), New Delhi organizes seminars, symposia, online & offline on tribal literature on regional as well as national levels. The Akademi also organizes a programme called "Loka – The Many Voices", consisting of

lectures as well as demonstrations. The programme was conceived to protect and preserve the tribal art and culture in the country.

The Akademi has established a North East Centre for Oral literature (NECOL) in Agartala to exclusively cater to these languages which bring out related publications and also organizes activities and programmes in these languages from time to time. These languages include Mizo, Ao, Garo, Chakma, Rabha, Karbi, Hmar, Lepcha, Khasi, Tangkhul, Missing, Tenydie, Kokborok, Jaintia, Tulu, Gojri and Ho etc. The Akademi has also translated books from these languages into English which would help translations into other Indian languages for the dissemination of this unknown literature into other linguistic community. The Akademi has also established an Oral and Tribal Literature Centre in Delhi to cater to the needs of other parts of the country.

### • Centre for Cultural Resources and Training (CCRT), New Delhi:

Regional Centres of CCRT have been established in tribal dominated areas i.e. Guwahati, Assam, Udaipur, Hyderabad and at Damoh, Madhya Pradesh for promoting the folk/ tribal art and culture through its training programmes and supporting tribal artisans and craft persons through its token honorarium for their valuable services.

Workshops-cum-training Programme were organized by CCRT at Guwahati exclusively for the tribal teachers on "Tribal Art and Culture and Enhancing Understanding of Indigenous Traditions" where a large number of teachers have been imparted training on preservation and promotion of art, culture and heritage of various tribal communities. Tribal teachers from tribal dominated States like Andhra Pradesh, Chhattisgarh, Gujarat, Jharkhand, Madhya Pradesh, Maharashtra, Odisha, Rajasthan, Tamil Nadu, Telangana and North-Eastern states regularly attend the CCRT training programmes.

CCRT has published a coffee table book on "Living Traditions - tribal and folk paintings of India" covering 18 genres i.e. Pithora from Gujarat, Gond from Madhya Pradesh, Warli from Maharashtra, Saura from Odisha, Santhal from West Bengal, Cherial and Kalamkari from Andhra Pradesh, Ganjifa, Kalighat and Patua from West Bengal, Madhubani from Bihar, Mata Ni Pachedi from Gujarat, Sanjhi from Haryana, Chitrakathi from Karnataka, Patachitra from Odisha, Kaavad, Picchvai and Phad from Rajasthan. The painting traditions of 573 tribes and tribal communities have been covered in this book. These patterns offer tangible evidence of legends that have been passed down orally in each tribe over centuries.

### ➤ Indira Gandhi Rashtriya Manav Sangrahalaya (IGRMS), Bhopal:

To preserve and promote the art, culture and heritage of various tribal communities across the country, the IGRMS organizes programmes like exhibitions, education programmes, workshops, performing art presentations, seminars etc. In additional to these regular activities, the following two annual programmes are also conducted by IGRMS:

i. Tribal Literature Festival (TLF): It was initiated with an aim to bring the cultural and literary reserves of tribal inhabitants into mainstream. The programme includes organization of events like reading/ reciting poetry, short story, traditional storytelling, seminar on tribal literature & languages, ethnic, cuisine, exhibitions and workshops on tribal painting/ artifacts. This

programme gives a chance to tribal writers to share and discuss their works.

**ii. Tribal Healers Workshops**: This programme is organized for tribal healers of the country with an aim to promote the medicinal knowledge of tribal healers. In the workshops, tribal healers from different parts of the country show their ethno-medicine/ traditional medicinal knowledge.

### > Anthropological Survey of India (AnSI), Kolkata:

AnSI is an autonomous research organization under Ministry of Culture which contributes in the preservation and promotion of tribal culture by carrying out extensive research on their social cultural and biological aspects. These research results are published in form of books and articles. In addition, AnSI has seven zonal ethnographic museums which help in preserving and showcasing the tribal culture of the regions where they are situated. AnSI also makes short visual documentaries on the tribal cultures and organizes various outreach programmes under which these short documentaries on tribal culture are exhibited for the purpose of creating awareness about the rich tribal cultural heritage of the country.

#### B. MINISTRY OF TRIBAL AFFAIRS:

Ministry of Tribal Affairs administers the schemes of "Support to Tribal Research Institutes" and "Tribal Festival, Research, Information and Mass Education" under which following activities have been undertaken to promote tribal culture:

- i. Research and documentation of Indigenous practices by tribal healers and medicinal plants, adivasi languages, agriculture system, dances and paintings etc. Details of such projects sanctioned to research organizations during the last 2-3 years are at **Annexure-II**.
- ii. To acknowledge the heroic and patriotic deeds of tribal people, Ministry of Tribal Affairs has sanctioned setting up of 10 Tribal Freedom Fighters Museums for exhibiting rich tribal cultural heritage of the region with details as under:

iii. To preserve and promote rich tribal cultural heritage and also to create general awareness amongst public, a searchable digital repository has been developed where all research papers, books, reports and documents, folks songs,

photos/ videos with their metadata are uploaded The repository currently has more than 10,000 photographs, videos and publications which are mostly done by Tribal Research Institutes (TRIs).

- iv. Ministry of Tribal Affairs provides funding to TRIFED for organizing Adi Mahotsav festival at National level and State level. State level festivals like Hornbill festival of Nagaland, Pawl-Kut festival of Mizoram, Medaram Jatra of Telangana are funded through Tribal Research Institute.
- v. TRIFED organizes Tribal Artisan Melas (TAMs) to identify new artisans and new products at the sourcing level in States/ Districts/ Villages for expanding the tribal producers base.
- vi. Ministry of Tribal Affairs also facilitates various research studies/ publication of books/ documentation including audio visual documentaries on promotion of rich tribal cultural heritage through various Tribal Research Institutes (TRIs) details of which are at **Annexure-IV**. Further, details of activities approved in respect of TRIs during last 2-3 years under the scheme 'Support to TRIs' are at **Annexure-V**.
- vii. Ministry of Tribal Affairs also organizes various Tribal Cultural Exchange Programmes. Details of such exchange programmes conducted during the last five years are at **Annexure-VI**.

Further, Ministry of Tribal Affairs administers a special scheme called Conservation cum Development Plan (CCD), meant for the 75 identified Particularly Vulnerable Tribal Groups (PVTG) in the Country. Under this centrally sponsored scheme, the grants are given to States and Union Territories inhabited by such tribal groups to ensure that along with development interventions, the culture of such communities is also preserved, protected and promoted. The Ministry allocates annual budgetary provision to the States/UTs where the PVTGs inhabit. Details of funds released to the State Governments during the last three years under the scheme of 'Development of PVTGs' are at **Annexure-VII**.
