**INCREASE IN EXPENDITURE FROM DISTRICT MINING FUND**

135. DR. KIRODI LAL MEENA:

Will the Minister of MINES be pleased to state:

- (a) whether any measures have been taken by Government to increase the expenditure from the district mining fund and, if so, the details thereof;
- (b) the guidelines to spend the funds from the district mining fund in the State of Rajasthan and the total amount spent in all the districts, including Dausa district, during the last three years, the work-wise details thereof; and
- (c) whether any Committee has been constituted for sanction of action plan and review of the above amount and, if so, the names of the Members of the Committee and the details thereof?

**ANSWER**

(a) & (b): Section 9B of MMDR Act empowers State Governments to establish District Mineral Fund (DMF) to take up development programmes in mining affected areas. Ministry of Mines has circulated guidelines for Pradhan Mantri Khanij KshetraKalyanYojna (PMKKKY) on 16.09.2015 to be implemented by the District Mineral Foundations (DMF) for taking up development and welfare projects/programs in mining affected areas. These guidelines are applicable to all the States including Rajasthan. Information about the total amount spent in all the districts, including Dausa district, during the last three years, is provided in annexure I.

(c): To ensure effective implementation of the PMKKKY scheme in transforming the living standards / social upliftment of people and development of areas affected by the mining related operations, a 2 – tier administrative set up for DMF consisting of Governing Council and Managing Committee has been proposed in the Model Trust Deed circulate by the Central Government. Accordingly, an administrative set up consisting of a two-tier mechanism for DMF has been included by the State of Rajasthan in the Rajasthan District Mineral Foundation Trust Rules, 2016. Details of administrative setup of DMF in the State of Rajasthan are provided in annexure-II.

Moreover, The Mines and Minerals (Development and Regulation) Amendment Act, 2021 which came into effect on 28.03.2021 empowers the Central Government to issue directions to the State Governments with respect to composition and functions of DMF. Accordingly Central Government has issued order on 23.04.2021 to all the States to include MPs, MLAs and MLCs in the Governing Council of DMF in the larger public interest
