### Schools with vocational training courses

#### 1137: Shri Subhash Chandra Singh:

Will the Minister of **Education** be pleased to state:

- (a) the State-wise total number of schools without vocational training courses as a percentage of total number of schools;
- (b) whether vocational training courses are being initiated in schools which do not have them; and
- (c) the number of schools that have started vocational training during the last three years?

# ANSWER MINISTER OF STATE IN THE MINISTRY OF EDUCATION (SMT. ANNPURNA DEVI)

- (a): Education being in the concurrent list of the Constitution, majority of the schools are under the domain of the respective State and UT Governments. Under Vocational Education component of the centrally Sponsored Scheme 'Samagra Shiksha', NSQF compliant vocational courses are offered to Students of Classes IX-XII of Government and Government Aided Schools covered under the scheme. The State-wise total number of such schools without vocational training courses as a percentage of total number of such schools is given at Annexure-I.
- (b) & (c): Under Samagra Shiksha, Government and Government Aided, Secondary and Senior Secondary Schools are approved for implementation of Vocational Education each year based on the Annual Work Plan & Budget (AWP&B) proposals of the States and UTs. The State/UT wise number of schools approved for vocational education courses during the last three years is given at **Annexure-II**.
