### **National Literacy Rate**

1145. SHRI M. MOHAMED ABDULLA:

Will the Minister of EDUCATION be pleased to state:

- (a) the National Literacy Rate in the country, State-wise;
- (b) the steps taken and schemes introduced under National Education Mission to eradicate illiteracy in the country and the details thereof;
- (c) the amount of funds allocated, disbursed and utilised under National Education Mission, scheme-wise and State-wise; and
- (d) the list of beneficiaries under the schemes of the Ministry, State-wise?

#### ANSWER

# MINISTER OF STATE IN THE MINISTRY OF EDUCATION (SMT. ANNPURNA DEVI)

- (a) A statement indicating the State/UT-wise Literacy rate in the Country as per the Census 2011 is at **Annexure-I.**
- (b) to (d) National Education Mission comprises Centrally Sponsored Schemes of Samagra Shiksha, Teachers Training & Adult Education and Rashtriya Uchchatar Shiksha Abhiyan (RUSA).

The Department of School Education and Literacy has launched the Samagra Shiksha - an Integrated Scheme for School Education, throughout the country as a Centrally Sponsored Scheme with effect from Financial Year 2018-19. This programme subsumes the three erstwhile Centrally Sponsored Schemes of Sarva Shiksha Abhiyan (SSA), Rashtriya Madhyamik Shiksha Abhiyan (RMSA) and Teacher Education (TE). It is an overarching programme for the school education sector extending from pre-school to class XII and aims to ensure inclusive and equitable quality education at all levels of school education. It envisages the 'school' as a continuum from pre-school, primary, upper primary, secondary to senior secondary levels. The States/UTs are assisted by the central government to implement the Samagra Shiksha as a programme for providing universal access and retention, bridging the gender and social category gaps in education and enhancement of learning level of children at all levels of school education. The scheme covers 1.16 million schools, over 156

million students and 5.7 million teachers of Government and aided schools across the country. A statement indicating the State/UT-wise details of central share released and expenditure incurred under the scheme of Samagra Shiksha since 2018-19 is at Annexure-II.

In order to improve literacy rate, a Centrally Sponsored Scheme of Adult Education namely Saakshar Bharat was implemented in the rural areas of 404 districts in 26 States and one UT, that had adult female literacy rate of 50 percent and below as per Census 2001, including left wing extremism affected districts, irrespective of their literacy rates, with special focus on women and other disadvantaged groups, since October 2009. The scheme was extended upto 31.03.2019. A statement indicating details of State/UT-wise funds sanctioned/ released under the Saakshar Bharat scheme during the implementation period of the scheme, i.e. 2009-10 to 2018-19 is at **Annexure-III**. During the implementation of Saakshar Bharat scheme, against the overall target of making 7 crore adult non-literates as literates, around 7.64 crore learners, having passed the biannual Basic Literacy Assessment Tests conducted by National Institute of Open Schooling (NIOS) between August, 2010 to March, 2018, were certified as literates. A statement indicating State/UT-wise target of enrolment of learners, learners appeared and declared successful in the biannual Basic Literacy Assessment Tests under the programme is at **Annexure-IV**.

A new Centrally Sponsored Scheme of Adult Education "Padhna Likhna Abhiyaan" was implemented in rural and urban areas of 33 states/ UTs during the financial year 2020-21, with a target of making 48.16 lakh adult non-literates as literates. A statement indicating details of State/UT-wise funds sanctioned/ released under the Padhna Likhna Abhiyaan during the financial year 2020-21 is at **Annexure-V**.

A Centrally Sponsored Scheme of Rashtriya Uchchatar Shiksha Abhiyan (RUSA) is being implemented by Ministry of Education with the aim of promoting access, equity and quality. The scheme aims to improve the quality of State Universities and colleges and enhance their existing capacities so that they become dynamic, demand-driven, quality conscious, efficient and forward looking and responsive to rapid economic and technological developments occurring at the local, State, national and international levels.

Under RUSA, State Higher Educational Institutions are supported under various components such as creation of Universities by way of up-gradation of existing autonomous colleges, creation of Universities by conversion of colleges in a cluster, Infrastructure Grants to Universities, Infrastructure Grants to Colleges, upgradation of existing degree colleges into Model Degree colleges, etc. A statement indicating details of State-wise details of number of units and amount approved under the various components of RUSA Scheme are at Annexure-VI
