1341. SHRI BIKASH RANJAN BHATTACHARYYA:

Will the Minister of ENVIRONMENT, FOREST AND CLIMATE CHANGE be pleased to state:

- (a) number of projects that has been identified under the State Action Plan on Climate Change (SAPCC) and the relevant missions under National Action Plan on Climate Change (NAPCC) in the year 2017-18,2018-19,2019-20, 2020-21 and 2021-22, Statewise data there of; and
- (b) number of identified projects that were implemented or funded under National Adaptation Fund for Climate Change (NAFCC), the State-wise, project-wise fund release report?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT, FOREST AND CLIMATE CHANGE (SHRI ASHWINI KUMAR CHOUBEY)

(a) and (b) National Action Plan for Climate Change (NAPCC) is the overarching policy framework to mitigate and adapt to the adverse impact of climate change in the country. It was launched in 2008 with 8 National Missions, which are -(i) National Solar Mission (ii) National Mission on Enhanced Energy Efficiency (iii) National Water Mission (iv) National Mission on Sustainable Habitat (v) National Mission on Sustainable Himalayan Ecosystem (vi) National Green India Mission (vii) National Mission on Sustainable Agriculture (viii) National Mission on Strategic Knowledge on Climate Change.

Subsequent to the NAPCC, State Governments were also encouraged to prepare State Action Plan on Climate Change (SAPCC) in consistence with strategies in the NAPCC. SAPCCs are policy documents of the States/Union Territories (UTs) outlining the actions in the state to tackle the impacts of climate change. Thirty-three States/UTs have prepared their SAPCC with guidance from Ministry of Environment, Forest and Climate Change (MoEF&CC).

In order to support adaptation actions in the country, MoEF&CC has established the National Adaptation Fund for Climate Change (NAFCC). NAFCC support adaptation projects that are State driven and are based on needs and priorities identified under the SAPCCs and the relevant Missions under the NAPCC. Till date, 30 adaptation projects are sanctioned in 27 States and UTs under NAFCC. The details of sanctioned amount, year-wise fund released to NAFCC projects across State/UTs is placed at Annexure I &II.
