#### ROADS CONSTRUCTED IN TAMIL NADU UNDER PMGSY

### 418 SHRI M. MOHAMED ABDULLA:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the total length of roads approved and constructed under the Pradhan Mantri Gram Sadak Yojana (PMGSY), State-wise;
- (b) the total length of roads approved and constructed under PMGSY, district-wise for the State of Tamil Nadu;
- (c) the mechanism implemented to ensure proper maintenance of roads built under PMGSY; and
- (d) the average amount of roads constructed per day under PMGSY, year-wise from 2016?

### ANSWER

# MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SADHVI NIRANJAN JYOTI)

- (a) A total of 7,77,646 km road length has been sanctioned and 6,78,374 km completed under various interventions/verticals of Pradhan Mantri Gram Sadak Yojana (PMGSY) as on 27<sup>th</sup> November, 2021. The details of road length sanctioned and completed, state-wise are given in **Annexure-I.**
- (b) A total of 22,458 km road length has been sanctioned and 20,479 km completed under various interventions/verticals of Pradhan Mantri Gram Sadak Yojana (PMGSY) in the State of Tamil Nadu as on 27<sup>th</sup> November, 2021. The details of road length sanctioned and completed, district-wise are given in **Annexure-II**.
- (c) Roads are being constructed and maintained under PMGSY as per the specification laid down in Ministry of Rural Development Specifications for Roads &Bridges published by Indian Road Congress (IRC) in 2014. As per PMGSY guidelines, maintenance of roads constructed under the programme is the responsibility of the state governments and all such road works are covered by initial five year maintenance contracts to be entered into along with the construction contract, with the same contractor, as per the Standard Bidding Document. Maintenance funds to service the contract are required to be budgeted by the State Governments and placed at the disposal of the State Rural Roads Development Agencies (SRRDAs) in a separate maintenance account. On expiry of this 5 year post construction maintenance, PMGSY roads are required to be placed under Zonal maintenance contracts consisting of 5 year maintenance including renewal as per maintenance cycle, from time to time, to be funded by the state governments.

As a measure of enhancing the focus on maintenance of roads during the defect liability period (five years from the date of completion of road) and streamlining the delivery of routine maintenance of PMGSY roads on the basis of performance based maintenance contract, Electronic Maintenance of PMGSY roads (eMARG) has been implemented in all the states.

eMARG is an online platform, used by all the states, that monitors maintenance of PMGSY works for five years from the date of completion (i.e. under Defect Liability Period-DLP).

eMARG is currently getting utilized across 27 states and 2 UTs by 1,254 (97%) Programme Implementation Units (PIUs). 11,466(89%) contractors have been onboarded on eMARG. Out of 42957 roads under DLP, 93% have been registered on eMARG. Since financial year 2019-20, payment of 4,27,810 bills amounting to a total of Rs. 970 crore has been made to contractors through eMARG. Out of which, Rs. 444.00 crore has been paid during FY 2021-22.

(d) The average pace of construction of roads per day under PMGSY since 2016-17 till 2020-21 is given below:

Year	Rate of construction per day
2016-17	129.93
2017-18	133.35
2018-19	134.26
2019-20	74.81
2020-21	100.48

It is pertinent to note that the progress in the years 2019-20 and 2020-21 has been affected due to COVID-19 related restrictions and adverse weather situations.
