**STATUS OF PMKVY**

**429. SHRI M. MOHAMED ABDULLA:**

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

- (a) the status of Pradhan Mantri Kaushal Vikas Yojana (PMKVY), the details thereof;
- (b) the list of centres set up in the State of Tamil Nadu, district-wise;
- (c) the amount of funds allocated, disbursed and utilised, State-wise;
- (d) the number of beneficiaries of PMKVY in Tamil Nadu, district-wise; and
- (e) the amount of funds allocated, disbursed and utilised for Pudukkottai district?

(a) Pradhan Mantri Kaushal Vikas Yojana (PMKVY) was launched in 2015. Presently, the third phase of PMKVY i.e. PMKVY 3.0 is being implemented across the country. The last date of enrollment under PMKVY 3.0 is 30.12.2021. Since inception, till 21.11.2021, 1.32 crore candidates have been benefitted from the PMKVY across the country.

(b) Under PMKVY, there is no mandate of establishing the training centres (TCs). The short term training is being implemented through empanelled TCs. Further, Ministry promotes establishment of model and aspirational skill centres known as Pradhan Mantri Kaushal Kendra (PMKK) in every district for imparting skill training in Public Private Partnership (PPP) mode throughout the country, including State of Tamil Nadu. The district-wise number of empanelled TCs including PMKK in the State of Tamil Nadu, as on 15.11.2021, is given at *column (a) of Annexure I*.

(c) The PMKVY (except PMKVY 1.0 (2015-16) has two components, namely Centrally Sponsored Centrally Managed (CSCM) component being implemented through National Skill Development Corporation (NSDC) and Centrally Sponsored State Managed (CSSM) component being implemented through State Skill Development Mission of the State/UT.

Under CSCM component of PMKVY, there is no provision of State-wise funds allocation. Since inception of the PMKVY i.e. 2015, as on 21.11.2021, an amount of Rs.

7,921.02 crore has been disbursed to implementing agency i.e. NSDC for the implementation of the scheme.

Under CSSM component of PMKVY, funds and corresponding physical targets have been allocated to the States for the implementation of scheme through State Skill Development Missions (SSDMs). Since incorporation of State component i.e. 2016, as on 21.11.2021, an amount of Rs. 1,187 crore has been disbursed to States of the implementation of the scheme. The State-wise funds allocated, disbursed and utilized by the State under PMKVY 2.0 and PMKVY 3.), as on 21.11.2021, is given at *Annexure II*.

(d) The district-wise number of beneficiaries in State of Tamil Nadu under PMKVY, since inception, as on 21.11.2021 is given at *column (b) of Annexure I*.

(e) Under PMKVY, there is no provision for district-wise allocation of funds.
