PANCHAYATS IN KARNATAKA

1196. SHRI K.C. RAMAMURTHY:

Will the Minister of PANCHAYATI RAJ be pleased to state:

- (a) the details of Panchayats in Karnataka, district-wise;
- (b) whether it is a fact that the 15th Finance Commission has also given funds for rural local bodies and, if so, the details thereof;
- (c) whether the Ministry provides computers to Panchayats under Rashtriya Gram Swaraj Abhiyan; and
- (d) the details of Panchayats in Karnataka that have been provided with computers so far, district-wise, and efforts being made to cover other Panchayats?

ANSWER

THE MINISTER OF STATE FOR PANCHAYATI RAJ (SHRI KAPIL MORESHWAR PATIL)

- (a) There are 229 Intermediary and 5975 village Panchayats in 31 District Panchayats in Karnataka. Details of Panchayats in Karnataka is at **Annexure I.**
- (b) The Fifteenth Finance Commission (XV FC) has submitted its interim report for the financial year 2020-21 and the final report for the period 2021-26, which have been accepted by the Government of India in respect of the recommendations for Rural Local Bodies. The XV FC Grant-in-aid is allocated to all tiers of the Panchayati Raj including the Traditional Bodies of Non-Part IX States and Fifth and Sixth Schedule areas in two parts, namely, (i) Basic (Untied) Grant, which constitutes 50 % for 2020-21 and 40 % for 2021-22 to 2025-26; and (ii) Tied Grant, which constitutes 50 % for 2020-21 and 60 % for 2021-22 to 2025-26. The basic grants are untied and can be used by RLBs for location-specific felt needs relating to the twenty-nine subjects enshrined

in the Eleventh Schedule of the Constitution, except for salaries and other establishment costs. The expenditure required for auditing of accounts by external agencies approved by the State Government, however, can also be borne from this grant.

The Tied grants can be used for the basic services of (a) sanitation and maintenance of ODF status, and this should include management and treatment of household waste, and human excreta and faecal sludge management in particular and (b) supply of drinking water, rainwater harvesting and water recycling. Statement of State wise / year wise allocation and release of XV FC Grants is at **Annexure – II**.

As per guidelines dated 23rd August, 2021 issued by MoPR towards utilization of XV FC Basic (Untied) Grants, providing sufficient and high bandwidth Wi-Fi digital network services within GP has been included as one of the works/activities that can be taken up with XV FC Basic (Untied) Grants.

(c) & (d) Yes Sir. 'Panchayat' being "local government", which is part of the State List of Seventh Schedule of the Constitution of India is a State subject and is the responsibility of the States. However, Ministry of Panchayati Raj (MoPR) supplements the efforts of the States, including Karnataka through its scheme of Rashtriya Gram Swaraj Abhiyan (RGSA), which includes providing computers to Panchayats. Under this scheme the State of Karnataka has not asked for any assistance for computers so far.
