DEMAND FOR JOBS IN MGNREGA

1232 SHRIDEREK O' BRIEN:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the steps being taken in lieu of absorption of more people for MGNREGA;
- (b) the budgetary utilization, out of the allocation of 2.84 billion person days under MGNREGA for 2020-21;
- (c) the amount of payments pending to the States; and
- (d) the amount of supplementary funds, if any, allocated for the same?

(a): Mahatma Gandhi National Rural Employment Guarantee Scheme (Mahatma Gandhi NREGS) is a demand driven wage employment programme which provide for the enhancement of livelihood security of the households in rural areas of the country by providing at least one hundred days of guaranteed wage employment in every financial year to every household whose adult members volunteer to do unskilled manual work. It provides fall back options for livelihood for the rural households when no better employment opportunity is available.

(b): The Budgetary allocation under Mahatma Gandhi NREGS for the financial year 2020-21 was Rs. 1,11,500.00 crore at Revised Estimate (RE) stage and an amount of Rs. 1,11,170.86 crore was released during the financial year. During financial year 2020-21, more than 389 crore persondays were generated under Mahatma Gandhi NREGS.

(c): State/UT-wise details of pending liabilities for wage component under Mahatma Gandhi NREGS as on 03.12.2021 are given at **Annexure-I**.

State/UT wise details of pending liabilities for material component under Mahatma Gandhi NREGS as on 03.12.2021 is given at **Annexure-II**.

(d): There is a budget allocation of Rs.73000 crore under Mahatma Gandhi NREGS during FY 2021-22. Recently, Ministry of Finance allocated additional funds of Rs.10,000 crore for Mahatma Gandhi NREGS as an interim measure. Further, allocation may be made upon assessment of demand during the Revised Estimate (RE) stage.
