WELFARE OF PVTGs

1255. SHRI K.R.N. RAJESHKUMAR:

Will the Minister of TRIBAL AFFAIRS be pleased to state:

- (a) whether it is a fact that there are 75 Particularly Vulnerable Tribal Groups (PVTGs) notified as on date in the country, if so, the details thereof, State-wise;
- (b) whether Government is implementing a Scheme, namely "Development of Particularly Vulnerable Tribal Groups (PVTGs)" which covers the identified PVTGs among Scheduled Tribes;
- (c) whether the activities/projects sanctioned under the scheme differ from State to State depending on their demand; and
- (d) the details of the funds sanctioned to States under the Scheme during the last three years, Statewise?

ANSWER

MINISTER OF STATE FOR TRIBAL AFFAIRS (SHRI BISHWESWAR TUDU)

- (a): Yes, Sir. The names of Particularly Vulnerable Tribal Groups (PVTG) in the country, State and UT-wise are given at **Annexure 1.**
- (b) & (c): Yes, Sir. Ministry of Tribal Affairs administers a scheme namely 'Development of Particularly Vulnerable Tribal Groups (PVTG)' specifically for the PVTG population. The scheme covers the 75 identified PVTGs in 18 States, and Union Territory of Andaman & Nicobar Islands. The scheme aims at planning their socio-economic development in a comprehensive manner while conserving the culture and heritage of such communities by adopting habitat level development approach. The scheme operates in the nature of Gap filling. Under the scheme, financial assistance is provided to the State/UT Governments based on their proposals for development of tribal people in the sectors of education, housing, agricultural development, animal husbandry, construction of link roads, installation of non-conventional sources of energy for lighting purpose, water supply and sanitation, social security or any other innovative activities targeted to bridge the critical gaps. The projects taken up under this scheme are demand driven and differ from State to State.
- (d): Details of funds released under the scheme in the past three years is indicated as under,

No proposals were however received for the years 2018-19 & 2019-20 from the UT Administration due to which fund release could not be made. For the current financial year 2021-22, an amount to the tune of Rs 252.11 lakh has already been released for activities related to infrastructure improvement in PVTG habitations in the UT.
