Will the Minister of JAL SHAKTI be pleased to state

- (a) whether the Kosi-Mechi Link Scheme has received investment clearance and, if so, the details of estimated total project funding needed;
- (b) whether it is a fact that a similar scheme like the Ken-Betwa link project has a funding ratio of 90 per cent (Centre): 10 per cent (State);
- (c) whether Government is considering to include the Kosi-Mechi Link Scheme also as a National Project with a funding ratio of 90 per cent (Centre): 10 per cent (State) and, if not, the reasons therefor and the expected funding pattern; and
- (d) the formalities still pending and timeline for its completion?

- (a) Investment Clearance of Kosi-Mechi Link Scheme has been accorded by Investment Clearance committee of Department of Water Resources, River Development and Ganga Rejuvenation under Ministry of Jal Shakti in its 14th Meeting held on 22.10.2020. The Estimated Cost of the project as per the approved DPR of Kosi-Mechi Link Project is Rs. 4,900 Crore at Price Level 2015-16.
- (b) Ken-Betwa link project (KBLP) is one of the Inter Basin Water Transfer links under National Perspective Plan (NPP). The KBLP was declared as a National Project in the year 2008. The funding pattern of this project as recommended by the Public Investment Board (PIB) is given at Annexure.
- (c) & (d) The proposal for inclusion of Koshi-Mechi Link Scheme as National Project was received in Ministry of Jal Shakti from Government of Bihar, vide their letter dated 19.08.2020. The High Powered Steering Committee for implementation of National Projects in its 12th meeting held on 24.11.2020 has recommended Kosi-Mechi Link Project for inclusion in the Scheme of National Project as per the guidelines. As per the guidelines of National Projects, funding pattern for eight North-Eastern States & Hilly states (Himachal Pradesh and Uttarakhand), funding pattern is 90 (Central): 10 (States) and for projects in other States, funding pattern is 60 (Central): 40 (States).
