REGISTRATION OF MSMEs UNDER URP

1704. SHRI BHASKAR RAO NEKKANTI:
SHRI SUJEET KUMAR:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) total number of Micro, Small and Medium Enterprises (MSMEs) registrations under Udyam Registration Portal (URP), increase in registrations post introduction of the URP and reasons for such an increase, if any;
- (b) whether Government is aware that an NSSO report found 633.88 lakh unincorporated non-agriculture MSMEs in India engaged in different economic activities;
- (c) whether it has undertaken any measures to further incorporate and attract enterprises from organised sector, if so, the details thereof, and if not, reasons therefor; and
- (d) whether Government is aware of the spatial concentration of registered MSMEs in certain States and, if so, reasons therefor?

ANSWER

(a): On 1st July, 2020, after adoption of new definition of MSMEs, a new registration portal 'Udyam Registration' has been launched by M/o MSME and 58,90,442 classified MSMEs are registered on the portal in All India (from 01.07.2020 to 30.11.2021). It is evident from the following table that more MSMEs are registering in each quarter on the portal.

(c): To further incorporate and attract enterprises from organised sector, Development Institutes (DI) under Ministry of MSME has carried out 423 awareness programmes. Also, registration counter had been set up in the recently held India International Trade Fair 2021.

The three biggest incentives for registration on the UDYAM portal by MSMEs are as follows:

- They can avail benefits of schemes implemented by the Ministry of MSME and State Governments/UTs. E.g. Haryana, Bihar, Maharashtra, Jharkhand, etc.
- They can avail benefits of Priority Sector Lending (PSL). RBI has issued a circular dated 21st August, 2020, wherein the lending under PSL category is linked to Udyam Registration.

(d): As per Udyam Registration, top 5 States in which maximum number of MSMEs registered are in Maharashtra (12,53,048) followed by Tamil Nadu (6,42,702), Gujarat (4,99,728), Rajasthan (4,84,707) and Uttar Pradesh (4,63,575). The reason for concentration of registered MSMEs is that those States have higher number of estimated MSMEs as per 73rd round of NSS Report on Unincorporated Non-Agricultural Enterprises' (July 2015- June 2016) conducted by Ministry of Statistics & PI (MoSPI).
