- (a) the details of SGST, CGST and IGST revenue collected so far from the State of Rajasthan under Goods and Services Tax (GST) during the last three years, year-wise;
- (b) the percentage-wise share of the said revenue collected SGST/CGST/IGST-wise during the last three years; and
- (c) the details of the refund revenue paid since the implementation of GST till now, month-wise?

- (c): The details of refund of CGST and IGST are given as per **Annexure II**. SGST refund is paid out of Consolidated Fund of States.
