CSR initiatives by CPSEs situated in the aspirational districts of Odisha

1830. SHRI SUJEET KUMAR:

Will the Minister of FINANCE be pleased to state:

- (a) list of Central Public Sector Enterprises (CPSEs) situated in the aspirational districts of Odisha, under Corporate Social Responsibility (CSR) and otherwise;
- (b) the details of new investments proposed to be undertaken through CPSEs in Odisha, and the total amount of investments undertaken so far in the State;
- (c) number of families displaced so far due to investments mentioned in (a) and (b), and the status of rehabilitation of these families;
- (d) number of people employed in these CPSEs for the past three years; and
- (e) whether CPSEs have witnessed a decrease in employment rate over the last year, if so, the reasons therefor?

ANSWER

THE MINISTER OF STATE FOR FINANCE (DR. BHAGWAT KISHANRAO KARAD)

(a) to (e): NITI Aayog has identified ten districts in the state of Odisha as aspirational districts, namely, (i) Dhenkanal, (ii) Gajapati, (iii) Kandhamal, (iv) Balangir, (v) Kalahandi, (vi) Rayagada, (vii) Koraput, (viii) Malkangiri, (ix) Nawarangpur, and (x) Nuapada. As per Public Enterprises Survey 2019-20, 5 operational Central Public Sector Enterprises (CPSEs), namely, (i) Eastern Investment Limited, (ii) Mahanadi Coalfields Limited, (iii) National Aluminium Company Limited, (iv) Orissa Mineral Development Company Limited, and (v) The Bisra Stone Lime Company Limited have their registered offices in Odisha. The details of investment made in the operational CPSEs and number of their employees during last three years are given below:
