# ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (DR. BHARATI PRAVIN PAWAR)

(a) to (c): State/UT-wise details of release of Central share of funds under Ayushman Bharat -Pradhan Mantri Jan Arogya Yojana (AB-PMJAY) are at Annexure.

The number of eligible beneficiary families under the scheme is approximately 10.74 crore (50 crore individuals).

As of 8<sup>th</sup> December 2021, an amount of Rs. 9417.76 crore is released to States and Union Territories as Central share of funds for the implementation of the scheme.
