## STATEMENT

### **STATEMENT REFERRED TO IN REPLY TO RAJYA SABHA STARRED QUESTION NO. 159\* FOR ANSWER ON 13.12.2021 REGARDING “PRADHAN MANTRI AWAS YOJANA IN BELAGAVI, KARNATAKA”**

(a) to (b): Under Pradhan Mantri Awas Yojana-Urban (PMAY-U), a total of 6,93,577 houses have been sanctioned in the State of Karnataka. Of the sanctioned houses, 4,66,100 houses have been grounded for construction; of which 2,47,291 houses have been completed/ delivered. 44,850 houses have been sanctioned in Belagavi district of Karnataka under the scheme. Of the sanctioned houses, 27,887 houses have been grounded for construction; of which 18,400 houses have been completed/ delivered.

(c) to (d): States/Union Territories (UTs) formulate project proposals as per their assessed demand of houses under PMAY-U in a phased manner based on their resources and get them approved by State Level Sanctioned & Monitoring Committee (SLSMC). After approval from the concerned SLSMC, States/UTs submit the proposals to the Ministry for approval of admissible Central Assistance by the Central Sanctioning and Monitoring Committee. Completion of projects generally takes 12-36 months under different verticals of the scheme. All the projects sanctioned within the scheme period i.e. till March, 2022 are to be completed as per the time schedules mentioned in respective Detailed Project Reports (DPRs).

(e): District-wise details of houses sanctioned, grounded for construction and completed in the State of Karnataka including that in Belagavi are annexed.
