### INDUSTRIAL TRAINING INSTITUTES (ITIS) FUNCTIONING IN THE COUNTRY

#### 2048: SHRI PARIMAL NATHWANI:

Will the Minister of Skill Development and Entrepreneurship be pleased to state:

- (a) the details of the Industrial Training Institutes (ITIs) functioning in the country at present along with skill trades being taught in these institutes, State-wise/UT-wise including Andhra Pradesh, Jharkhand and Gujarat;
- (b) the number of students being taught in these institutes and the existing vacancies in various categories along with the plan to fill up these vacancies, State-wise/UT-wise, including Andhra Pradesh, Jharkhand and Gujarat; and;
- (c) whether Government proposes to set up new ITIs in the country and if so, the details thereof, State-wise?

#### ANSWER

## MINISTER OF STATE IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP (SHRI RAJEEV CHANDRASEKHAR)

- (a) The details of Industrial Training Institutes (ITIs) functioning State/ UT- wise including Andhra Pradesh, Jharkhand and Gujarat are attached at **Annexure** I. A total of 143 (one hundred and forty-three) NSQF compliant Skill trades (76 Engineering trades, 62 Non-Engineering trades and 5 Divyang trades) are running in the ITIs.
- (b) The number of trainees learning in the ITIs and existing vacancies under Craftsman Training Scheme (CTS) State-wise details, including Andhra Pradesh, Jharkhand and Gujarat, are attached at **Annexure II.** To fill up vacancies, advisories have been issued to all the States/ UTs where in various activities have been suggested to boost admission process under the guidelines issued by respective State/ UT Government.
- (c) The establishment of ITIs is a subject matter of State/ UT. However, if any proposal is sent by State/ UT for setting up of ITIs, these are examined as per the affiliation norms of the DGT. The state-wise new it is affiliated for the session 2020 and 2021 are attached at **Annexure-III**.
