**FACILITIES FOR WOMEN IN STATE-RUN MENTAL HEALTHCARE INSTITUTIONS**

2067 : SMT. VANDANA CHAVAN:

Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state:

- (a) whether Government has undertaken any national audit of state-run mental healthcare institutions in the country and if so, details thereof and if not, reasons therefor;
- (b) the number of mental healthcare institutions in the country, especially for women, State/ UT-wise;
- (c) the percentage of such mental healthcare institutions possessing child care facilities and basic sanitary products for women;
- (d) whether Government is aware that many such mental healthcare institutions are granting inadequate basic facilities for women; and
- (e) if so, the details of monitoring and redressal mechanism for the same and the remedial steps taken to ensure dignity of life?

**ANSWER**

MINISTER OF WOMEN AND CHILD DEVELOPMENT  
(SHRIMATI SMRITI ZUBIN IRANI)

(a): The Government has not conducted any national audit of state-run mental healthcare institutions in the country.

(b): As per available information, there are 47 Government Mental Health Institutions in the country, including 44 State run Institutions and three Central Mental Health Institutions. The State/ UT-wise list of Mental Health Institutions in the country is at **Annexure-I**.

(c) to (e): As per Section 20 of the Mental Healthcare Act, 2017, every person with mental illness shall have a right to live with dignity. Further, the Act provides that every person with mental illness to be protected from cruel, inhumane or degrading treatment in any mental health establishment and have the following rights, namely:

- a. to live in safe and hygienic environment;
- b. to have adequate sanitary conditions;
- c. to have reasonable facilities for leisure, recreation, education and religious practices;
- d. to privacy;

- e. for proper clothing so as to protect such person from exposure of his body to maintain his dignity;
- f. to not be forced to undertake work in a mental health establishment and to receive appropriate remuneration for work when undertaken;
- g. to have adequate provision for preparing for living in the community;
- h. to have adequate provision for wholesome food, sanitation, space and access to articles of personal hygiene, in particular, women's personal hygiene be adequately addressed by providing access to items that may be required during menstruation;
- i. to not be subject to compulsory tonsuring (shaving of head hair);
- j. to wear own personal clothes if so wished and to not be forced to wear uniforms provided by the establishment; and
- k. to be protected from all forms of physical, verbal, emotional and sexual abuse.

As per Section 77 of the Act, any person with mental illness or his nominated representative or a representative of a registered non-governmental organization, with the consent of such a person, being aggrieved by the decision of any of the mental health establishment or whose rights under this Act have been violated, may make an application to the concerned Mental Health Review Board seeking redressal or appropriate relief.
