**ALLOCATION OF FUNDS TO BIHAR FOR IMPLEMENTING AGRICULTURAL
SCHEMES**

2263. SHRI SUSHIL KUMAR MODI:

Will the Minister of AGRICULTURE AND FARMERS WELFARE be pleased to state:

- (a) the funds received by the State of Bihar from the Central Government during the last three years for agricultural schemes and agricultural mechanization, year-wise;
- (b) whether the State Government of Bihar sent two letter for sanctioning ₹ 395.48 crores under Sub-Mission on Agricultural Mechanization scheme for the year 2021-22 but the approval has not been received yet; and
- (c) if so, the reasons for this delay and by when approval would be given?

- (a) A Statement indicating the funds released by Department of Agriculture & Farmers Welfare to the Government of Bihar under various major schemes during the last three years is enclosed as Annexure-I.
- (b) and (c) During the year 2021-22, the Government of Bihar has submitted an annual action plan amounting to Rs. 395.48 Crore (Rs. 241.24 Crore Central Share and Rs. 154.24 Crores State Share) under Sub-Mission on Agricultural Mechanization (SMAM). Bihar State is yet to submit utilization certificate for funds released in 2020-21.
