2587. SHRI DEREK O' BRIEN:

Will the Minister of CORPORATE AFFAIRS be pleased to state:

- (a) the quantum of funds collected under Corporate Social Responsibility (CSR) scheme for the past five years;
- (b) the collection amount of CSR funds, State-wise;
- (c) the fields where developmental works have been undertaken using these funds and in which States; and
- (d) the details of quantum of funds?

(a) to (d): The broad framework for Corporate Social Responsibility (CSR) has been provided under Section 135 of the Companies Act, 2013 ('Act'), Schedule VII of the Act and Companies (CSR Policy) Rules, 2014. Schedule VII of the Act indicates the eligible list of activities that can be undertaken by the companies as CSR. Under the Act, CSR is a Board driven process and the Board of the company is empowered to plan, decide, execute and monitor CSR activities based on the recommendations of its CSR Committee.

The CSR framework is disclosure based and CSR mandated companies are required to file details of CSR activities annually in the MCA21 registry. All data related to CSR filed by companies in MCA21 registry is available in public domain at www.csr.gov.in. On the basis of the filings made by companies in the MCA 21 registry, CSR spent by the companies during the financial year 2016-17 to 2020-21 is given below:

States/Union Territories (UTs) wise and Development Sector-wise details of CSR spent by the companies during the financial year 2016-17 to 2020-21 are at Annexure - I and Annexure - II respectively.

Regarding CSR data for financial year 2020-21, it is informed that the companies are required to hold Annual General Meeting (AGM) within six months from the end of financial year. Thereafter, financial statements and board reports containing disclosures about CSR, are to be filed in MCA21 within 30 days of the AGM. In view of the disruption caused by COVID-19 pandemic, Registrars of Companies have accorded extension of time till 30th November, 2021 for conduct of AGMs by companies. The Ministry vide General Circular No. 17/2021 dated 29.10.2021 has relaxed the levy of additional fees till 31.12.2021 for filing of financial statement in respect of the financial year 2020-21.
