REGISTRATION OF HIGHER GROWTH RATE INDUSTRIAL SECTOR

2499. SHRI IRANNA KADADI:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) whether the Micro, Small and Medium Enterprises (MSMEs) sector has been consistently registering higher growth rate than the overall growth of the industrial sector in the country during the last Five Year Plan;
- (b) if so, the details thereof along with the percentage growth rate in production, establishment of new units and employment generated during the said period, State/UT-wise;
- (c) whether the growth registered by the MSMEs sector is lagging behind the target fixed during the said period; and
- (d) the steps taken by Government to achieve the higher growth rate of MSME sector?

ANSWER

MINISTER OF MICRO, SMALL AND MEDIUM ENTERPRISES (SHRI NARAYAN RANE)

(a) to (c): As per the information received from National Statistical Office (erstwhile Central Statistics Office), Ministry of Statistics & Programme Implementation, share of MSME Gross Value Added (GVA) in All India GDP at current prices for the year 2015-16, 2016-17, 2017-18, 2018-19 and 2019-20 were 29.5%, 29.3%, 29.7%, 30.5% and 30.0% respectively.

As evident from the above figures, the share of MSME GVA in all India GDP is hovering around 30%.

As per 73rd Round of NSS Report on Unincorporated Non-Agricultural Enterprises (July 2015- June 2016) conducted by Ministry of Statistics & PI (MoSPI), the estimated number of MSMEs in All India was about 6.34 crore. The State/UT—wise numbers of MSMEs are given at Annexure-I.

As per 73rd Round of NSS Report on Unincorporated Non-Agricultural Enterprises (July 2015- June 2016) conducted by Ministry of Statistics & PI (MoSPI), the estimated number of persons employed in MSMEs are about 11.10 crore. The State/UT-wise numbers of persons employed in MSMEs are given at Annexure-II.

(d): The Ministry of Micro, Small and Medium Enterprises (MSMEs) implements various schemes to achieve the higher growth rate of MSME sector. These includes Prime Minister's Employment Generation Programme (PMEGP), Micro and Small Enterprises-Cluster Development Programme (MSE-CDP), Scheme of Fund for Regeneration of Traditional Industries (SFURTI), Credit Guarantee Fund Trust for Micro and Small Enterprises (CGTMSE) and A Scheme for Promoting Innovation, Rural Industry & Entrepreneurship (ASPIRE).

Government has taken a number of initiatives under Aatma Nirbhar Bharat Abhiyan to support the MSME Sector in the country especially in Covid-19 Pandemic. Some of them are:

- i. Rs 20,000 crore Subordinate Debt for MSMEs.
- ii. Rs 3 lakh crores Collateral free Automatic Loans for business, including MSMEs upto Rs. 4.5 lakhs.
- iii. Rs. 50,000 crore equity infusion through MSME Fund of Funds.
- iv. New revised criteria for classification of MSMEs.
- v. New Registration of MSMEs through 'Udyam Registration' for Ease of Doing Business.
- vi. No global tenders for procurement up to Rs. 200 crores, this will help MSME.
