# ENERGY FROM URBAN, INDUSTRIAL, AGRICULTURAL WASTES/ RESIDUES AND MUNICIPAL SOLID WASTE PROGRAMME

Will the Minister of NEW AND RENEWABLE ENERGY be pleased to state:

- (a) whether the Government has launched the programme on "Energy from Urban, Industrial, Agricultural Wastes/ Residues and Municipal Solid Waste";
- (b)if so, the details thereof; and
- (c)the funds sanctioned for the implementation of the programme till date and a State-wise break up thereof?

#### ANSWER

### THE MINISTER OF NEW & RENEWABLE ENERGY AND POWER

(SHRI R.K. SINGH)

(a) to (c) Programme on Energy from Urban, Industrial, Agricultural Wastes/ Residues and Municipal Solid Waste for recovery of energy in the form of Biogas or BioCNG or Power or Producer Gas from municipal solid waste, industrial and agricultural waste / residues was notified on 30.07.2018 initially without the MSW component initially with a budget outlay of Rs 78 Crore and a physical target of 57MWeq. The scheme was revised on 28.02.2020 to include the MSW component with a revised budget outlay of Rs 478 Crore and a physical target of 257MWeq. The programme which was valid till 31.03.2021, has been recommended for continuation by EFC for the period FY 2021-22 to 2025-26 for only meeting the already created liabilities. Thus, no new projects after 31.03.2021 are to be sanctioned.

Central Financial Assistance (CFA) under the Programme for setting up Waste to Energy plants is granted on successful commissioning and performance testing. The details of CFA are as follows:

- (a) Biogas generation : Rs 1.0 Crore per 12000 cum/day (Maximum Rs 10 Crore/project); ;
- (b) BioCNG generation (including setting of Biogas plant): Rs 4.0 Crore per 4800 Kg/day (Maximum Rs 10 Crore/project);
- (c) Power generation based on Biogas (including setting of Biogas plant): Rs 1.5 Crore to Rs 3.0 Crore per MW (Maximum Rs 10 Crore/project);
- (d) Power generation based on MSW: Rs 5.0 Crore per MW (Maximum Rs 50 Crore/project);
- (e) Biomass Gasifier:
- Rs. 2,500 per kW<sub>e</sub> with duel fuel engines for electrical application
- Rs. 15,000 per kW<sub>e</sub> with 100% gas engines for electrical application

- Rs. 2 lakh per 300 kW<sub>th</sub> for thermal applications.
- Electrical: Rs.10,000 per kWe for 100% producer gas engines with Gasifier system in industries & other institutions.
- Electrical: Rs. 8000 per kWe for 100% producer gas engine alone in industries & other institutions.

As on 31.03.2021, a cumulative CFA of Rs 298.83 Crore has been sanctioned to various developers for setting up of Waste to Energy plants. State-wise details of CFA sanctioned by MNRE is given at **Annexure**.
