- (a) whether Government proposes to set up a network of skill development centres/institutes across the country;
- (b) if so, the details thereof including targets fixed by Government for the purpose during the current year and next two years and the achievements made so far, State-wise/UT-wise;
- (c) whether Government also proposes to involve private sector for this purpose and if so, the details thereof; and
- (d) whether any arrangements have been made for providing advanced training to trainers for ensuring the quality of training and if so, the details thereof?

- (a) Yes Sir.
- (b) The details of Skill development centres/institutes of Ministry of Skill Development and Entrepreneurship (MSDE) across country are given below:

MSDE Schemes such as Pradhan Mantri Kaushal Vikas Yojana (PMKVY), Jan Shikshan Sansthan (JSS), and Craftsman Training Scheme (CTS) are demand driven. Demand for these schemes depends on many factors like the state of the economy, consequent derived demand for skills and sector-wise matching of demand and supply etc. in addition to State

Governments' cooperation especially in the matter of establishing and managing ITIs and in maintaining a common standards framework in the skilling eco-system. State-wise network of Skill Development Centers achieved so far is attached in Annexures I to IV.

(c) Yes, Government involves Private-Sector Skill Development Centers/Institutes actively. Pradhan Mantri Kaushal Kendras have been established under PPP mode. Jan Shikshan Sansthan are Non-government organizations participating in Skilling Ecosystem. There are 3,178 Govt. ITIs & 11,533 Private ITI's running courses under Craftsmen Training Scheme. There are 19,517 Private-Sector Establishments providing apprenticeship training under National Apprenticeship Promotion Scheme.

(d) National Council for Vocational Education and Training (NCVET) has mandated that all trainers in ITIs need to be Crafts Instructor Training Scheme (CITS) trained. Such trainers are trained in National Skill Training Institutes (NSTIs) and Institutes of Training of Trainers (IToTs). Details of trainers trained are attached at Annexure V. The Sector Skill Councils have certified 61,617 trainers so far. Detail is attached in Annexure VI.
