- (a) the details of craftsmen training centre opened by Government during the last three years under its long-term training programme, State-wise;
- (b) the number of students trained and employed during the last three years under long term training programme, State-wise;
- (c) whether Government have any policies for placement assistance or support for selfemployment for such trained persons; and
- (d) if so, the details thereof?

- (a)The details of Industrial Training Institutes (ITIs) opened by Government under long-term training programme under Craftsman Training Scheme (CTS) in last three years is attached at Annexure –I.
- (b), (c) & (d) The establishment and day-to-day administration of ITIs comes under the jurisdiction of State Government, while Central Government has the responsibilities for setting up the criteria for affiliation, examination, certification and designing curriculum. The number of students enrolledunder long-term training programme under CTS in last three years is attached at *Annexure II*. As perreport of the Tracer Study of ITI Graduates 2018 conducted by the Ministry of Skill Development and Entrepreneurship through Mott MacDonald, an Independent Agency, 63.5 % of ITI Graduates are employed of which 6.7 % are self-employed. The policies for placement assistance or support for self-employment are part of administration in ITIs.
