(a): The number of Micro, Small and Medium Enterprises (MSMEs) of North Karnataka region that are registered on Udyam registration portal till date are given below:

- (b): The above listed units are registered with Udyam Registration. The functional/Non-functional MSME data are not available
- (c) & (d): Government of Karnataka launched New Industrial Policy 2020-25 on 13/8/2020 for the Industrial development of the state.

As per this industrial policy the various incentives and concessions are available to the MSMEs set up under New/ Expansion/ Modernization/ Diversification program such as:

- 1. Investment promotion subsidy
- 2. Stamp duty exemption
- 3. Registration charges concessions
- 4. Electricity Tax exemption
- 5. Reimbursement of land conversion fee
- 6. Power subsidy
- 7. Rain water harvesting
- 8. Waste water recycling
- 9. Reimbursement of expense incurred for water audit
- 10. Zero discharge
- 11. Recycling of electronic waste and plastic waste
- 12. Subsidy for setting up ETP

The taluks have been classified as Zone-1 (most backward taluks), Zone-2 (more backward taluks) and Zone-3 (Industrially developed taluks). All the taluks of North Karnataka region have been classified as Zone-1 (Most backwards districts) hence, higher rate of incentives are available to the units setup in these districts.
