STATUS OF CHILD AND ADULT BEGGARS IN INDIA

445. SMT. VANDANA CHAVAN

Will the Minister of SOCIAL JUSTICE AND EMPOWERMENT be pleased to state:-

- (a) the State/UT-wise details of adult and child beggars for the last 10 years;
- (b) whether Government is aware that the number of beggars has increased since the 2011 Census;
- (c) whether it is a fact that begging is a crime in India, as per State laws;
- (d) the details of schemes for uplifting the beggar population in India and reducing the organised crime of beggary in the country, along with any impact evaluation of the same carried out, and if not, the reasons therefor; and
- (e) the details of scheme-wise beneficiaries and their eligibility criteria?

ANSWER

- (a) & (b) As per the information available on the website of Registrar General of India, numbers of adult and children (Age up to 19 years) engaged in the act of Begging are attached at **Annexure**. These figures are based on Census 2011.
- (c) Most of the States/UTs have adopted "The Bombay Prevention of Begging Act 1959" which criminalize the act of Begging. The High Court of Delhi, had struck down various Sections of the Bombay Prevention of Begging Act, 1959 as extended to Delhi which criminalize the begging or treating begging as offence, stating them as unconstitutional.
- (d) & (e) Ministry of Social Justice and Empowerment has formulated a scheme "SMILE Support for Marginalized Individuals for Livelihood and Enterprise", which includes sub-scheme 'Central Sector Scheme for Comprehensive Rehabilitation of persons engaged in the act of Begging'. This scheme covers several comprehensive measures including welfare measures for persons who are engaged in the act of begging.

The focus of the scheme is extensively on rehabilitation, provision of medical facilities, counseling, basic documentation, education, skill development, economic linkages and so on. Persons engaged in the act of Begging are to be covered under the scheme.
