

SHRI SHAHID SIDDIQUI (Uttar Pradesh): Sir, I associate myself with the matter raised by the hon. Member.

### **Draft National Mineral Policy**

MR. CHAIRMAN: Next is, Shri Panda. Mr. Panda, please bear in mind the three-minute rule.

SHRI B.J. PANDA (Orissa): Sir, I seek the same indulgence that you have showed to the previous Member.

Sir, I raise a matter of very serious national concern which is of particular concern to this House. Sir, this is the Council of States. We represent, not individual constituencies, but the concern of States. The hon. Prime Minister is a Member of this House. Sir, the matter that I raise is that the Chief Ministers of five States, namely, Orissa, Chhattisgarh, Jharkhand, Karnataka and Rajasthan have been writing to the Prime Minister, seeking to meet him to raise a matter of serious importance concerning their States, but are not getting time. This is a matter of serious concern. Sir, this is not something that I am speculating. I have here with me letters from Shri Naveen Patnaik; I have letters from Shri Madhu Koda of Jharkhand; I have a joint representation signed by the Chief Ministers of all the five States; and, Sir, I was part of a delegation of about twenty-five MPs from these five States who went to meet the Prime Minister who himself told us that he has limited time and he cannot meet these Chief Ministers on this issue. ...*(Interruptions)*...

Sir, the issue is, the Draft Mineral Policy which is today being prepared. Sir, this is something that we need to understand because it has a critical impact on the economies and the livelihoods in these five States. Sir, these five States account for about ninety per cent of the minerals in this country. These are mostly poor States which have suffered from national neglect and active discrimination for more than fifty years.

Sir, I just want to cite two examples. One example is, policies like freight equalisation for fifty years took away the natural economic advantages of these States and they suffered for five decades. Sir, on the issues of royalties, these States get a pittance in royalties. Sir, instead of following the world-wide practice of *ad valorem* royalties, there are administered royalties, and I can show you the abuse that happens. Royalties are supposed to be revised every three years. ...*(Interruptions)*...

SHRI B.J. PANDA: One minute. Sir, in recent years, these States have started making changes in policies which are helping them to improve their economic condition. Sir, these policies involve value addition which requires investment in the States for operating mines. As a result, hundreds of thousands of crores of investment are coming to these States.

SHRI B.J. PANDA: Sir, I will complete in just thirty seconds. Sir, I can talk for Orissa where Orissa has become a revenue-surplus State only in the last few years because of these policies on minerals. Our GDP growth rate has now started exceeding the national average. Sir, I cannot understand why this national policy has to be done in secrecy. ...*(Interruptions)*... Sir, all Departments of this Government today put up their draft policies on the Website, and it is discussed in public. **Right of Chief Ministers to Voice their views and opinions  
with Prime Minister**

THE LEADER OF THE OPPOSITION (SHRI JASWANT SINGH): Mr. Chairman, Sir, we have experienced a little obstruction in the normal functioning of the House. I will not go into other issues like Member 'A' getting time and Member 'B' not getting time. But that is the reality too. However, Sir, here in this case, there was a grievance expressed by certain Members on account of the difficulty that the Prime Minister had in meeting the Chief Ministers of five States. The central question here is of the respect that is accorded to the principle of federalism and the Chief Ministers of States. I do know, Sir, that a Group of Ministers was constituted. A very senior Member of the Cabinet the Union Home Minister has chaired it. Perhaps a report has already been considered by the Cabinet or is going to be considered. The hon. Members are of the view, Sir, and they have said that the Chief Ministers wanted to call on the Prime Minister after the Group of Ministers had concluded their job. On that occasion also, the Prime Minister had had difficulty in meeting the Chief Ministers, that is from where this grievance is borne.

Also, Sir, if various other policies can be put on the website and the opinion of the larger public can be obtained or solicited a policy like minerals—whether major or minor mineral—also merits such equal treatment. If that too is put on the website, then where would be the difficulty? And I do believe, Sir, that the Chief Ministers have a right to voice the grievances or opinions or the views of the State as they have the honour to be heads of Governments. That is the point. If the Government would respond to it, we would be very grateful. We have no intention of interrupting the functioning.

We do wish to hear the hon. External Affairs Minister, and I am encouraged by the fact that the hon. the Prime Minister is here. He perhaps comes here with the intent of clarifying some of the issues that are being raised as direct questions to him. He would benefit by hearing all this. Perhaps, the Chairman of the Group of Ministers will respond and clarify the situation.
