Will the Minister of Electronics and Information Technology be pleased to state:

- (a) whether Government has received proposals for setting up of Software Technology Parks (STPs) and electronic hubs in the country;
- (b) if so, the details thereof, State-wise;
- (c) the action taken by Government to set up such parks, electronic hubs and Hardware Technology Parks in Tamil Nadu; and
- (d) the time by which the proposals are likely to be approved?

(a) to (d): A Statement is laid on the Table of the House.

STATEMENT REFERRED TO IN REPLY TO RAJYA SABHA STARRED QUESTION NO. *252 FOR 25.03.2022 REGARDING SETTING UP OF SOFTWARE TECHNOLOGY PARKS AND ELECTRONIC HUBS

(a): Yes, Sir. Based on the proposals received from the respective State Governments, Software Technology Parks of India (STPI), an autonomous society under Ministry of Electronics and Information Technology has set-up 62 Software Technology Parks of India (STPI) centres across the country. Further, 22 new STPI centers have been approved by Government of India.

Ministry of Electronics and Information Technology (MeitY) had notified Electronics Manufacturing Clusters (EMC) Scheme in October, 2012 to provide support for the creation of world-class infrastructure along with common facilities and amenities for attracting investments in the electronics sector. The Scheme was closed for receipt of application from October, 2017. Under the scheme, 19 Greenfield Electronics Manufacturing Clusters and 3 Common Facility Centres (CFCs) were accorded approval in 15 States across the country.

Based on further requirement for strengthening of infrastructure to create robust electronics manufacturing ecosystem in the country, MeitY has introduced Modified Electronics Manufacturing Clusters (EMC 2.0) Scheme on 1st April, 2020 which is open for receipt of application upto March, 2023. Under the EMC 2.0 scheme, 2 applications for setting up of EMC project in the state of Andhra Pradesh and Haryana have been approved.

- (b): The state-wise list of existing and approved STPI centres is at **Annexure-I and Annexure-II.**The details of EMCs approved under Electronics Manufacturing Clusters (EMC) Scheme and Modified Electronics Manufacturing Clusters (EMC 2.0) Scheme are at **Annexure-III and Annexure-IV.**
- (c): Till date, 5 STPI centres have been set-up in the State of Tamil Nadu at Chennai, Coimbatore, Madurai, Tirunelveli and Trichy.

The Modified Electronics Manufacturing Clusters (EMC 2.0) Scheme is open for receipt of applications for development of electronic manufacturing clusters across the country.

(d): As of now, no new proposal for setting up of STPI centre in the State of Tamil Nadu is under consideration of GoI. Further, MeitY has not received any application for setting up of Electronics Manufacturing Cluster (EMC) in the State of Tamil Nadu.
