#### ASSISTANCE TO FPIs IN KARNATAKA

#### 1223. SHRI IRANNA KADADI:

Will the Minister of *Food Processing Industries* be pleased to state :

- (a) whether Government has provided assistance to Food Processing Industries (FPIs) in Karnataka during the last two years and the current year;
- (b) if so, the details thereof, industry and location-wise;
- (c) whether Government has fixed any time limit for accepting the proposals and providing assistance:
- (d) if so, the details thereof; and
- (e) whether Government has taken any steps to reduce the prescribed time limit and if so, the details thereof?

#### **ANSWER**

### THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (SHRI PRAHLAD SINGH PATEL)

(a) to (e): The Ministry of Food Processing industries (MoFPI) has been implementing Central Sector umbrella scheme - Pradhan Mantri Kisan SAMPADA Yojana (PMKSY) for overall growth and development of food processing sector across the country including Karnataka. Under component schemes of PMKSY, MoFPI provides mostly credit linked financial assistance (capital subsidy) in the form of grants-in-aid to entrepreneurs for setting up of food processing / preservation industries. So far, Ministry has approved 2 Mega Food Park projects, 16 Cold Chain projects, 4 Agro Processing Clusters, 18 Food Processing Units, 3 Creation of Backward & Forward Linkages Projects & 9 Food Test Laboratory projects in Karnataka for assistance under corresponding component schemes of PMKSY. Details of these projects along with location is placed at **Annexure**.

MoFPI is also implementing a Centrally Sponsored Scheme - PM Formalisation of Micro Food Processing Enterprises Scheme (PMFME) for providing financial, technical and business support for setting up/upgradation of 2 lakh micro food processing enterprises across the country through credit linked subsidy during five years from 2020-21 to 2024-25 with an outlay of Rs. 10,000 cr. Out of this, a total of 11910 units have been allocated to Karnataka and Rs 49.93 Crore has been released to the state so far.

PMKSY is not any region or state specific but demand driven and financial assistance is provided to the eligible applicants selected on the basis of Expression of Interest (EoI) issued from time to time. Selection of suitable proposals is done regularly as per the Scheme guidelines, based on the merit, through a transparent appraisal process as per the prefixed criteria. As selection process involves appraisal & scrutiny of proposals at multiple levels, including through Inter-Ministerial Approval Committee (IMAC), no specific time limit is prescribed in this regard in PMKSY, though MoFPI makes every effort for its expeditious disposal. Grants to assisted projects is disbursed immediately after achieving prescribed benchmarks within budgetary constraints.
