Will the Minister of JAL SHAKTI be pleased to state:

- (a) whether Government is taking any steps to promote solid and liquid waste management in rural areas under Swachh Bharat Mission (SBM)-Gramin;
- (b) if so, the details thereof and State-wise extent of progress achieved so far in this regard, including Rajasthan;
- (c) if not, by when such proposal is likely to be implemented; and
- (d) the quantum of funds allocated for the SBM-G in rural areas during each of last three years, the State-wise details thereof, including Rajasthan?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF JAL SHAKTI (SHRI PRAHLAD SINGH PATEL)

- (a) to (c) Swachh Bharat Mission (Grameen) [SBM (G)] Phase-II is being implemented during the period from 2020-21 to 2024-25 with the focus to sustain Open Defecation Free (ODF) status and to cover all villages with Solid and Liquid Waste Management (SLWM). State/UT-wise details of progress achieved regarding SLWM, as reported by the States/UTs on the online Integrated Management Information System (IMIS) of SBM (G), are given at **Annexure-1**.
- (d) SBM (G) is a demand driven scheme. Hence, fixed State/UT-wise allocation of funds is not made under the programme. The details of Central share funds released under SBM (G) during the last 3 years, State/UT-wise, are given at **Annexure-2.**
