HUGE GAP BETWEEN SANCTIONED AND OPERATIONAL AWCS AND MAWCS

*298. DR. KANIMOZHI NVN SOMU:

Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state:

- (a) whether there is a huge gap between the number of sanctioned and operational Anganwadi Centres (AWCs) and Mini-Anganwadi Centres (MAWCs) in the country during last three years;
- (b) if so, the details thereof and the reasons therefor, State-wise/UT-wise;
- (c) whether a large proportion of the said Centres are operating/running from rented buildings/semi-pucca buildings/open/partially covered spaces and do not have basic amenities such as toilets, potable water, separate kitchen, medicine kits, etc.;
- (d) if so, the number of such centres in the country, State-wise/UT-wise; and
- (e) the steps taken to provide them the basic facilities?

ANSWER

MINISTER OF WOMEN AND CHILD DEVELOPMENT (SHRIMATI SMRITI ZUBIN IRANI)

(a) to (e): A Statement is laid on the Table of the House.

Statement referred to in reply to Part (a) to (e) of Rajya Sabha Starred Question No.298 by Dr. Kanimozhi Nvn Somu to be answered on 30.03.2022 regarding "Huge gap between sanctioned and operational AWCs and MAWCs".

- (a) & (b) State/UT-wise number of sanctioned and operational Anganwadi Centres (AWCs) during the last three years is at Annexure-I.
- (c) & (d) As on 30.06.2021, out of the total 1389110 operational AWCs, 1255675 AWCs are running in pucca buildings, 164783 AWCs do not have drinking facilities and 286310 AWCs do not have toilet facilities. State/UT-wise number of AWCs operating from pucca/semi-pucca government/rented buildings alongwith number of AWCs without drinking water facilities and toilet facilities is at Annexure-II.
- (e) The following steps have been taken for development of infrastructure at AWCs:
 - Revised joint guidelines were issued by Ministries of Women & Child Development, Rural Development and Panchayati Raj for construction of 4 lakh AWC buildings across the country under Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) in convergence with Anganwadi Services (ICDS Scheme);
 - ii. Under Swachhta Action Plan, Rs.10,000/-per AWC is provided for drinking water facilities and Rs.12,000/-per AWC for toilet facilities;
 - iii. Grants are sanctioned for purchase of water filter, furniture, equipment, etc;
 - iv. Anganwadi Workers (AWWs) have been provided with Smart Phones for efficient service delivery;
 - v. Streamlined guidelines were issued on 13.01.2021, covering several aspects such as quality assurance, roles and responsibilities of duty holders, procedure for procurement, integrating AYUSH concepts and Data management and Monitoring through 'Poshan Tracker' for transparency, efficiency and accountability in delivery of Supplementary Nutrition

Recently, the Anganwadi Services Scheme has been subsumed under Saksham Anganwadi and Poshan 2.0. Under Saksham Anganwadi and Poshan 2.0, 2 lakh AWCs @ 40,000 AWCs per year would be strengthened, upgraded and rejuvenated for improved nutrition delivery including Poshan Vatikas for stimulating the creative, social, emotional, cognitive and intellectual development of children under 6 years of age in convergence with education development programmes, providing/adding more services with better infrastructure including internet/wifi connectivity, LED screens, water purifier/installation of RO Machine and Early Childhood Care and Education with smart learning aids, audio-visual aids and child friendly learning equipments.
