- (c) whether Railways have rehabilitated the slum dwellers in the vicinity, if so, the Statewise and city-wise details as on date, if not, the reasons therefor?

(a) and (b): As on 31.03.2021, the total land in possession of Indian Railways is about 4.84 lakh hectares. Railways do not maintain State-wise and city-wise details of Railway land and encroachments. Only zone-wise details/data of total land and encroachments are maintained by Railways. Zone-wise details of Railway's total land and land under encroachment/illegal occupation which includes slums are as under:-
