CRAFTSMEN TRAINING SCHEME

3966. SHRI DEREK O'BRIEN:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

- a) the budget allocation for the Craftsmen Training Scheme since its inception and the current FY 22-23, year-wise, details thereof;
- b) how many craftsmen have benefitted so far? details thereof; and
- c) whether Government has launched or plans to launch any women specific training schemes regarding art and handicrafts, if so, the budget allocation for the same, the details thereof?

- a) Craftsmen Training Scheme is for providing long-term training in 143 trades through Industrial Training Institutes (ITIs) across the country. There are 33 National Skill Training Institutes across the country which also impart courses under Craftsmen Training Scheme. Setting up of ITIs and its operation are in the domain of respective State Governments, whereas preparation of norms and designing curricula along with conducting examination and certification are the responsibility of Central Government. Hence, there is no provision for allocation of funds under Craftsmen Training Scheme.
- b) The detail of ITIs functioning across the country along with the Number of Trainees enrolled under Craftsmen Training Scheme (CTS) is given in Annexure – I. The detail of NSTIs functioning across the country along with the Number of Trainees enrolled under Craftsmen Training Scheme is given in Annexure-II.
- c) While there are no women specific schemes for training schemes regarding arts and crafts in Industrial Training Institutes, Government has made a provision of 30% reservation of seats for women candidates all over the country in Industrial Training Institutes. The Government has in place the policy to develop the teaching process in the way of training of trainer's development programme and conducts the programme through 19 National Skill Training Institutes which are exclusively for women in 15 states/UTs of India.

Under Skill India Mission, more than 20 central Ministries/Departments are running schemes/programs to impart skill training to the youth including women. Ministry of Skill Development and Entrepreneurship is implementing a flagship scheme Pradhan Mantri Kaushal Vikas Yojana (PMKVY) to impart short duration skill development training to youth including women of the country. Under PMKVY, training has been imparted in various job roles of 37 different sectors including job roles of traditional arts and crafts under Handicrafts and Carpet Sector Skill Council (HCSSC).

Under PMKVY, as on 31.12.2021 since 2016, 2,62,880 candidates have been trained/oriented (20,196 trained under STT and 2,42,684 oriented under RPL) in various traditional job roles in the country. Out of the total 2,62,880 trained candidates, 1,72,105

candidates are females while 90,547 candidates are males. Some of the traditional job roles are Bamboo Basket Maker, Bamboo Mat Weaver, Beading Artisans, Carpet Weaving, Carving Artisans, Tarakashi Jeweller, Decorative Painter, Sketching & Painting Artisans, Hand Rolled Agarbatti Maker, Crochet Lace Trailers, Hand Embroiderer etc.

Ministry through NSDC is implementing several special projects under PMKVY targeting artisans' clusters in partnership with private sector in a manner where 100% artisans are ensured employment. Under this, special project to revive the traditional Namda craft of Jammu & Kashmir and Upskilling of Weavers & Artisans on traditional crafts of Nagaland and Jammu and Kashmir are being implemented.

The Scheme of Jan Shikshan Sansthan(JSS) for Skill Development is a Central Sector Scheme. JSSs are imparting skill training to non-literate, nonliterates, persons. Under JSS, as on 01.04.2022 since 2017, 15,68,619 candidates have been trainedout of which women percentage is 85%.
